# Introduction

---

This manual is designed to assist Club Secretaries and Show Secretaries to properly complete the appropriate paperwork for the running of Championship & Open Shows.

It is to remain with the Club and be passed on when the Secretary or Show Secretary is changed. The prices mentioned are current from 1 January 2011 and may change. Any changes will be published in the Dog World and a letter sent to the Clubs. If in doubt please ring the Dogs Queensland office.

## Timings

---

### *SCHEDULES*

Schedules are published in the Dog World Magazine 2 months prior to the show and are required to be in the CCCQ office 3 Months prior to publication. For example a show that is held in June is published 2 months prior in the April Edition of the Dog World. The completed schedule along with judges contracts and advertising fee is to be received by the Dogs Queensland office in January, 3 Months prior to Aprils Publication.

### *R10'S*

The R10 is the post show paperwork and is to be received by the Dogs Queensland office within 14 days of the shows completion along with the Admin Fee (formally known as Surcharge). The only exception to this is if there is an Incident at the show in which case it is required to be received within 2 working days of the show.

### *OVERSEAS JUDGES*

If the club is contracting an overseas judge for their show from any country apart from New Zealand an application for non resident judge is to be completed and sent to the Dogs Queensland office for approval by the ANKC. This application is to be received at least 9 Months prior to the show.

# SCHEDULES

---

Schedules are the forms that are completed with the details of the show, Dates, Time, Judges ect. and are due into the office 3 months before publication. The Forms are to be completed in Triplicate and submitted to the Dogs Queensland in Duplicate along with the judges contracts and the advertising fee.

You are required to submit a separate schedule for each show.

Incomplete schedules cannot be approved and may result in the clubs show being cancelled. Late Schedules may also have the same result.

In the back of this manual you will find examples of correctly filled in Schedule forms and a Check List for completing them

# JUDGES CONTRACTS & BASIC RULES

---

There are two types of Judges contracts one for Australian & New Zealand Judges and the other is for other countries.

The Australian Judges Contracts are fairly straight forward and self explanatory. They are a self carbonating form in quadruplicate. The White copy is sent with your schedule, The blue is sent to the office by the judge, the Pink is kept by the judge and the yellow is kept by the club. They are to be FULLY completed by the judge see the example in the back of this manual.

Overseas Judges contracts are to be 6 pages and are to be completed in full. They are available from our website or the ANKC website. They are to be submitted to the Dogs Queensland office at least 9 months prior to the show accompanied by a letter from the Overseas governing body and a cheque for the appropriate fee made payable to the ANKC.

If you are unable to obtain a letter from the Overseas Body the ANKC can obtain it on your behalf for an additional fee.

## *Rules for appointing Judges*

The complete rules for appointing Judges are in the Dogs Queensland Rule book however the following are some basic rules to follow:

1. General Specials;

The senior judge officiating at a show is to judge General Specials.

For All Breeds Championship shows Conducted by Kennel Clubs and Agricultural Societies the judge must be an All Breeds Judge.

For All Breeds Open Shows they must have at least 5 Groups

2. A Championship Judge cannot judge the same group or breeds at shows within 6 months or 200Kms of each other. The distance is calculated AS THE CROW FLIES not by road.

An Open Show Judge cannot judge the same group or breeds within 4months or 100Kms of each other .

3. Sweepstakes Judges for shows within 112Kms of Brisbane must be All Breeds Judges outside this area they must have at least 4 Groups at Champ level and 3 at Open.

4. If more than 200 entries are received for a single Judge then another judge is to be appointed for the extra numbers.

5. The judge is to receive from the club at least 7 days prior to the show a list of the breeds and the numbers of each to be judged on the day



# FEES

---

## *Schedule Fees*

SHOW TYPE	1/4 PAGE	1/2 PAGE	FULL PAGE
CHAMPIONSHIP	\$125	\$190	\$365

Note these fees are current as at 1 January 2011 and are subject to change. See the Dog World for updated fees.

The minimum size for all shows is 1/4 Page per show.

If the club is holding a Championship & Open Show Back to Back then the Championship fees apply. Fees are calculated on the total size of the advert e.g. 2x1/4= 1/2

A clubs second Open Show for the year is advertised for FREE.

# R10'S

---

R10'S are the forms submitted after your show and are submitted along with the Show Results form (Champ Shows Only) Show Managers report, a Marked Catalogue and any incident reports if they are required. The form is also known as a Surcharge form.

There are 4 types of R10's one for Champ & Open Shows held at Durack, One for Champ Shows Not held at Durack, One for Open Shows Not held at Durack and one for Agricultural Societies. I'll deal with them individually and include examples at the back of the manual.

## *Shows at Durack*

The Admin fees for shows held at Durack are calculated as follows

Champ Shows. Ground levy \$3.00 Per entry excluding Property Classes.

Plus 10% of the total entry Fees Plus GST.

Open Shows: For open Shows you only pay the Ground Levy which is calculated at \$1 per entry or for All Breeds Clubs \$150, For Group Clubs \$80 for Breed Clubs \$40 which ever works out the greater amount.

If you are holding a double Open Show then you pay the Ground Levy on Both Shows

If you are holding a Championship & Open Show together then you only pay the Ground Levy for the Championship Show.

#### *Club Shows not held at Durack*

For shows not held at Durack as of 1 January 2010 the Administration fee for CHAMPIONSHIP SHOWS ONLY is a flat 10% of the total entry fee Plus GST.

For OPEN SHOWS there is NO Admin Fee however the R10 paperwork is to be completed and submitted as usual so as we can keep a track of the entries.

#### *Agricultural Societies*

The Administration Fee for Ag Societies is 20% of total entries Plus GST

# INCIDENTS AT SHOWS

---

The complete rules for handling incidents can be found in rules 249 to 259 of the Dogs Queensland rule book however below is a brief outline of the procedures.

## *Aggressive Dogs*

If at a Show or other sanctioned event a dog shows ANY sign of aggression towards any Person or other dog the incident is to be reported in writing to the Show Manager /Chief Steward on the day of the incident before the closing of the Show.

The show officials are to gather written witness statements and hold a meeting of the Club/Show committee and look at all the statements including the owner/exhibitor's statement.

If the complaint has been proved the Committee is to inform the Owner of the dog in writing that it has been suspended for 6 Months and send the Show Managers report along with all statements and a report of the proceedings of the meeting to the Dogs Queensland office within 2 working days of the show.

## *Incidents involving members*

Incidents involving Members at a Show or other Club activities of any kind are to be reported to the Show manager or appropriate Club Official (President/Secretary) immediately. All the details are and witness statements are to be taken and a Comprehensive report is to be submitted along with the Show Managers report within 2 working days of the incident.

If a exhibitor, club member or member of the public is injured at a show or event it is to be reported to the Show manager or appropriate Club Official (President/Secretary) immediately. All the details are and witness statements are to be taken and a Comprehensive report is to be submitted along with the Show Managers report within 2 working days of the incident.

The Schedule is to be completed in triplicate (the third copy to be retained by club)

If appointing an overseas judge it is the responsibility of the club to obtain a clearance from the relevant overseas control and have the judge complete an ANKC judge's form. (When contracting a judge from overseas (New Zealand being the exception) you must apply to the CCC(Q) who will apply for a clearance from the ANKC on your club's behalf.)

When contracting judges for your show please remember to include ALL classes, breed/s & special classes that they will be judging. It is the club's responsibility to ensure that Rules 204 to 211 are not infringed.

**Agricultural Societies** - if appointing a Show Secretary for the Dog Section you must attach a copy of appointment of agency with your schedule. Exhibitors at Agricultural Societies Championship Shows must be given FREE ENTRY PASSES in the ratio of:- one free pass for one or two dogs, two free passes for three or more dogs. Exhibitors must pay car parking fees where required.

Entries Closing date must be at least 21 clear days prior to the date of the show.

Clubs/Societies are reminded that they must cater for Trophies/Sashes for the following: Breed, Group & General Specials winners. **Note:** Minimum value of trophies - 20% of entry fees (excluding cost of sashes); the value of trophies should be appropriate having regard to entries.
