



### **Expressions of interest to provide Coffee for the Durack Show Grounds**

Expressions of interest are sought to provide Coffee and related products at the Dogs Queensland Sports Grounds at 247 King Ave, Durack in 2018.

In return for the payment by the approved Vendor of a lump sum or a per cup sold basis, Dogs Queensland (Licensor) agrees to grant a License to operate a vending operation at the Dogs Queensland Sports Grounds at 247 King Avenue, Durack from a designated site on every occasion that an approved Event is staged on the Sports Grounds under the following conditions;

1. The Licensor agrees to allow the Licensee to operate a vending operation from the designated site for sale of Coffee and related products.
2. This agreement commences on 1 January 2018 and expires on 31 December 2018.
3. The Licensee agrees to pay all fees 48 hours post Show on a per cup basis or quarterly on an annual basis.
4. For Events commencing in the Morning, you would be expected to be in attendance from 1 hour prior to the Show until at least the Luncheon interval. For Events commencing post Midday, you would be expected to be in attendance from 1 hour prior to the Show until at least the Evening meal break.
5. The Licensee agrees (if) not working out of a Demountable Building that they will remove their Caravan, Trailer, Van, Truck, Tent or Gazebo after the Show leaving the Site clean for the Grounds Manager to mow.
6. The Licensor will mark out the designated site and display signage to identify that site.
7. The Licensee agrees to the responsibility of tagging all Electrical Cords and Appliances used at their Site.
8. All Professional Vendors are to display a current Certificate of their qualifications at all times.
9. The Licensor will issue a Permit Certificate to the Licensee for display when using the site.
10. The Licensee shall have exclusive use of the designated area during the current agreement, subject to the conditions specified in this agreement.

11. The Licensee agrees:

- a. To keep vending operations at the Dogs Queensland Sports Grounds within the confines of the designated area;
- b. Not to sub-let the designated site to another operator;
- c. To display the Permit Certificate issued by the Licensor when operating the site;
- d. Not to use the site as a parking area when not in use for vending;
- e. To arrange for public liability insurance cover of at least \$2 million relative to their operation during this agreement and to produce evidence of such cover for the Licensor prior to commencement of this agreement;

NB: Dogs Queensland reserves the right to appoint additional Coffee Vendors at events where large numbers of public are in attendance, eg the All Dogs Sports Spectacular
