PRIMARY REPORTS

Chairperson's Report

On Behalf of the Board I submit the following report for members' consideration upon the activities of the company during the last proceeding financial year.

Financial Results

Dogs Queensland's funds have increased over budget by \$54,766. This surplus is due to total income exceeding the budget projection by \$72,868 (4%), and our total expenses were more than the projection by \$12,761 (1%). Our capital expenditure for the year was \$160,157, which had been budgeted at \$121,572.

I thank the General Manger and Mr Wayne Chapple for their personal contribution to maintenance of the budget throughout the year.

Dogs Queensland Staff and Committees

Mr Rob Harrison and his Staff are the Company's most valuable asset and they deserve the grateful thanks of the Board and the Membership for their efforts over the past year. I note their length of service and main areas of responsibility below;

Durack - Chair Miss C Pearen

The Durack Committee worked tirelessly in 2014. They achieved 85% of their forward plan for the year. The Camping Project will be ongoing in 2015, which should see it completed.

The late November Storm destroyed a lot of big trees, hopefully they will be replaced with some help from the local Council this year. Members' participation with the clean-up was greatly appreciated.

Strategic Planning Committee - Chair Mrs U Greenwood

This Committee achieved its goal for 2014, with the Dogs Queensland Plan 2015-2019 to be viewed on the Dogs Queensland Website and available by request from the Dogs Queensland Office.

Conformation Judges Committee - Chair Ms S Bendixen

The Conformation Judges Committee completed the 2013/2014 lectures and held Theory and Practical exams for the Trainees. An Accreditation Training Seminar for Judges was also held, conducted by Glenys Alexander (Chairperson of the Victorian Judges Training Scheme). In 2015 the CJC will commence conducting many Seminars, the first is planned to be "Members Education Lectures" in April 2015.

This is to ensure that our country Members receive the same standard of education as their metropolitan counterparts. The ADSS Working Party are busy organising for a bigger and better event in 2015.

Amenities Committee - Chair Ms R Nicholson

Amenities Shows were successfully held in all Zones, but due to the vastness of Queensland the Board has reviewed and decided that although Robyn and her Committees have put in a fantastic effort, it would be easier for the Durack Committee to take on the Zone 1 Amenities Shows and that a Committee in both Zones 2 and 3 be organised for their Amenities Shows for 2015. A huge thank you to Robyn and her Committee for taking on this mammoth undertaking in 2014.

Junior Handlers Committee - Chair Mr I Rasmussen

As Queensland will be hosting the National in 2017, this Committee will definitely have their work cut out for them in the way of major fundraising for the Gala Event, as well as ensuring that our Junior Handler's training is always a priority.

DOY Committee - Chair Mr T Thomas

After the successful 2014 DOY/POY event, this Committee is fully focused on 2015 with fundraising and support Shows to organise, to ensure that the Dogs Queensland Gala Event will be successfully held and improvements made on last year's events.

Obedience and Rally O

We thank these gentlemen for their continued contributions. This Subcommittee is also working very hard fundraising for the National Trial for Obedience and Rally-O in 2015.

Tracking and Track and Search

Successfully conducted Judges training in Queensland by the way of mentoring systems. The drought this year has caused a few problem with the sourcing of Venues.

Agility

The National Agility Trial at Durack in June 2014 was highly successful. The media coverage was definitely a high point for the Agility Trial and Dogs Queensland.

Herding

A Judges Training scheme is currently being planned and developed. Training should commence in 2015.

Endurance

Criteria has been developed for Judges Training. Prospective applicants can view the criteria on the Dogs Queensland Website.

Dances with Dogs

Queensland will be hosting the Inaugural National Dances with Dogs Competition at Durack in June 2015.

Lure Coursing

After many years of demonstrations at Durack and other areas in Australia, the ANKC has sanctioned the new discipline. Competitions will be conducted at Durack in 2015.

Into the Future

2015 will be a huge year for Dogs Queensland, not only with multiple disciplines holding Nationals, but with the Canine Health and Welfare Committee conducting our first Seminar to help our Breeders and outside organisations (Australian Veterinary Association) with knowledge and understanding of the Dogs Queensland training and processes. Members raised various concerns, during the Strategic Planning process, which will be addressed through various components of Seminars to be put in motion in conjunction with the Conformation Judges Committee in 2015. This year will be a year of new initiatives that will benefit Dogs Queensland and its members.

Government and Agency Liaison Officer Report

Annual Report (year ending December 2014)

Report Submitted by Mark Sheppard - Dogs Queensland Government and Agency Liaison Officer

The year that was 2014 promised to be full of new challenges and opportunities for Dogs Queensland. Before I share some of the outcomes from the year just ended (and some of my predictions for 2015) I would like to take a moment to reflect. In the early hours of December 30th 2013 my family and I were thrown a real curve ball with the sudden and unexpected death of my 84yo Mum in her sleep. Ours is a very close knit family and to a large extent we are still feeling our loss very deeply.

The recent holiday season was our first without Mum and it would seem that for us Christmas / New Year will in future always be a time for reflection – so different to the way we would usually celebrate the Festive Season. Could I take this opportunity to formally thank the many dog world friends who sent us cards and emails, and messages of condolence via social media – they were all very much appreciated and certainly helped us through what was a very tough time.

Now down to business - one objective that was really top of mind for me in early 2014 was to finalise the submissions I had made to Ipswich City Council in respect of our Breeder Permit Scheme. To date three formal submissions had been made to that Council and all of the indications were that a decision was pending regarding the acceptance and implementation of our proposal. Then without warning things started to unravel – a member had received a visit from an authorised Ipswich CC Inspector acting on a barking complaint.

In all of my dealings with Local Government Authorities I really promote the fact that our Dogs Queensland members are responsible owners who abide by local laws as they pertain to dogs. I also remind Councils that it is a requirement of our Dogs Queensland Code of Ethics that our members abide by all canine related Federal, State and Local laws.

Unfortunately on the day that our member received a visit from her Council inspector there were 5 dogs residing at the premises and none were registered with the Council. Contrary to the information provided to me by the member there had been numerous complaints in the past ranging in severity – barking dogs while the owner was out, dogs escaping the property and roaming local streets and on one occasion a dog escaping the yard and bailing up the postman on the footpath.

Whilst I have no hard evidence to back this up there is no doubt in my mind that this series of events has resulted in Ipswich City Council now deciding to delay their decision (to implement our Breeder Permit Scheme) pending a review – so very disappointing given all of the time and effort invested in this Local Council. There are a significant number of Dogs Queensland members residing in the Ipswich catchment area and negotiating a better outcome for those members has been at the top of my list now for almost 3 years.

What this example demonstrates very clearly is that every member has a responsibility (both as an individual and as a group of like minded enthusiasts) to support each other. I can't promote the benefits and virtues of Government bodies supporting Dogs Queensland (both the Organisation and our members) if our members let the team down.

It seems that every month we are receiving requests from Local Councils asking that we confirm membership status – members can't find their membership card or remember their membership number when filling in permit renewals so they just leave the space blank. A number of members have also been "caught out" over the past 12 months exceeding the number of dogs that they are permitted to keep (usually a maximum of 9 where the breeder permit scheme has been adopted).

We have also received complaints involving dogs being kept in crates and cages in garage sheds – in fact one case was so bad that the RSPCA was called in to seize 14 dogs.

You don't need me to tell you that this is simply unacceptable and (in my mind) beyond my comprehension.

I am sure that the vast majority of our members are doing the right thing and exceeding every measure in the manner that they keep and care for their dogs. But it doesn't take much for our reputation to be tarnished – it has taken me many years and innumerable man hours to build our enviable reputation with State and Local Government Authorities yet at times it seems that certain individual members are putting us all at risk by their poor management practices and total disregard for the laws governing dogs.

As a new year begins (and resolutions are made) could I ask that all members consider how they currently keep their dogs and that improvements are made as required. I do know that our Board is also getting very tired of receiving reports of non compliance and whilst it is not my place to pre-empt what action may be taken I would not be at all surprised to see some members facing breaches charges as a result of their tardiness – if that is what it takes to pull members back on track then so be it.

Lets all work together to grow our Organisation during 2015 and protect the reputation of Dogs Queensland as an absolute priority.

In closing it is probably timely that I clarify a couple of things in respect of communication channels. Far too often over the past 18 months I have logged on to my Facebook account to find a significant number of work related messages from members. I rarely log on to social media more than once or maybe twice a month and I do so for personal contact not as a part of my job.

Could we agree please that in future all matters relating to your dealings with State and Local Government or Welfare Groups like the RSPCA be sent to me via email to the Office? That way I can assist you in a timely fashion and provide advice as appropriate. More importantly it allows me to save your correspondence to a specific file which ensures things don't go missing on my operating system.

If I need to refer back to your concerns or check what correspondence I may have sent on your behalf I can find all of that information quickly.

The same applies to telephone calls – whilst I operate very effectively from a home office it is my home and taking calls out of hours can be difficult and frustrating. It is not unusual for the home phone to ring after 10.00pm at night with a member on the line asking for my urgent assistance. Can I please request that where possible phone calls are received within business hours.

And whilst I am on the topic of phone calls please don't ring the mobile 4, 5 even 6 times in a row – this happens regularly. The reason I don't always pick up is quite straightforward – I am in a bad signal area, I am already on the phone, I am in a meeting or I recognise your number and I have an idea of why you are calling but probably haven't had an opportunity to dig out the information you were seeking.

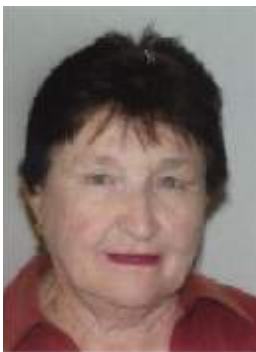

Principal Activities

The Company was registered as a Company Limited by Guarantee on 10 September 2012, having previously operated as an unincorporated association.

The principal activities of the Company during the year were the registration and promotion of purebred dogs. No significant change in the nature of those activities occurred during the year.

Key Performance Measures

The Company measures its own performance through the use of both quantitative and qualitative benchmarks. The benchmarks are used by the Directors to assess the financial sustainability of the Company and whether the Company's short-term and long-term objectives are being achieved. The Key Performance Measures used are Renewing Full Single Members 3,480 (2013 - 3,570), Full Joint Members 1,262 (2013 - 1,312), New Members 796 (2013 - 792), Litter Registrations 14,954 (2013 - 14,064), Renewing Prefixes 3,078 (2013 - 3,168), New Prefixes 350 (2013 - 363) and Transfers of Dogs 3,701 (2013 - 3,693).

Members Guarantee

Canine Control Council (Queensland) Limited is a Company Limited by Guarantee. In the event of, and for the purpose of winding up of the Company, the amount capable of being called up from each member and any person or association who ceased to be a member in the period prior to the winding up, is limited to \$1. The number of members at the end of 2014 was 6,652 (2013 - 6,737).

Operating Results

The consolidated profit of the economic entity for the financial year amounted to \$119,766.

Subsequent Events

No matter or circumstance has arisen since the end of the financial year, which has significantly affected or may significantly affect:

- (a) the Company's operations,
- (b) the result of those operations,
- (c) the Company's state of affairs.

Dividends

The company is prohibited under its constitution from payment of dividends to its members.

Indemnification of Company Officers and Auditors

During the financial year, the company paid a premium in respect of a contract ensuring the Directors of the company (as named above), the company secretary and all executive officers of the Company and of any related body corporate against liability incurred as such a Director, Company Secretary or Executive Officer to the extent permitted by the Corporations Law.

The Company has not otherwise, during or since the end of the financial year, indemnified or agreed to indemnify an officer or auditor of the Company or of any related body corporate against a liability incurred as such an officer or auditor.

Directors' Benefits

Within the financial year, no Director of the Company has received or become entitled to receive any benefit by reason of a contract made by the Company or a related Corporation with the Director or with a firm of which he is a member or with a Company in which he has a substantial financial interest.

Objectives:

The objectives of the Company shall be:

1. To be the governing canine body for the State;
2. To maintain membership of the National Canine Body and to enhance and promote its standing within that body;
3. To promote and encourage the development and responsible breeding of healthy purebred registered dogs throughout the State;
4. To promote and encourage the recreation, sport, exhibition and training of the CCCQ Ltd registered dogs throughout the State
5. To promote and encourage the training of all dogs throughout the State;
6. To promote the development and improvement of the health and welfare of purebred registered dogs throughout the State;
7. To promote and encourage membership of the CCCQ Ltd with its attendant advantages and privileges;
8. To promote and develop policies and regulations that shall be used as a quality benchmark for dog breed standards ensuring that the welfare and health of dogs remains paramount;
9. To promote, develop and maintain close working relationships with all levels of Government (Commonwealth, State and Local) to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
10. To promote, develop and maintain close working relationships with other organisational bodies and other stakeholder groups with similar objectives to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
11. To promote and encourage public interest and participation in the CCCQ Ltd sanctioned exhibitions and events;
12. To promote and encourage scientific research into canine related health issues both in Queensland and interstate;

13. To act as the control of the CCCQ Ltd registered dog related activities throughout Queensland including:

- (i) to administer Rules for the conduct and regulation of all the CCCQ Ltd exhibitions and events;
- (ii) to keep a register of purebred dogs and their ownership;
- (iii) to keep a register of all breeder prefixes;
- (iv) to administer regulations relating to purebred dogs;
- (v) to grant or withhold affiliation to bodies with similar objectives referred to as affiliated bodies;
- (vi) to administer certificates, awards, championships and titles;
- (vii) to assist in the prevention of illegal or dishonest practices in relation to dog related activities in Queensland; and
- (viii) to facilitate the operation of independent registers for Non-Conformation activities including registers for non-purebred dogs;

14. To promote and encourage development of knowledge and skills relating to canine activities.

To achieve these objectives, the entity has adopted the following strategies:

- Attract and retain qualified staff to administer the business of the entity and provide member services which meet consistent standards of best practice as compared to similar entities and this is evidenced by low staff turnover
- Attract and retain volunteers from within the membership who are committed to the entity's objectives
- Both staff and volunteers will continue to work towards both the entity's short and long term objectives
- Continue to keep open the lines of communication with all Government bodies on all aspects of purebred dogs
- Collect, verify and publish information relating to purebred dogs and the breeding and exhibition of purebred dogs
- Keep and maintain a canine register of purebred dogs
- Promote the holding of exhibitions and to conduct exhibitions
- Charge fees for all aspects of the business that the company conducts.

During 2014, the Conformation Judges Committee has successfully completed the 2013/2014 lectures and held theory and practical examinations for trainees.

My appreciation must go to all the Group and Regional coordinators who facilitate these lectures and to those assessors who help out at the practical examinations (especially under the wet conditions in 2014!). In the latter part of the year, we held an accreditation training seminar for judges.

This was conducted by the chairperson of the Victorian Judges Scheme, Glenys Alexander. In addition to providing accreditation training, Glenys presented very interesting and informative lectures on Interpretation of Breed Standards and Critiquing.

The revised format for our Distance Education trainees is working well. Distance trainees have structured guidelines for submitting assessments, critiques etc. This has ensured that their lecture format is on the same timeline as the metropolitan trainees. They are assisted by the regional facilitators, who organise breed days, critiques at shows and sweepstakes in their area for the trainees.

Open Shows in some northern areas are again proving difficult for Clubs to conduct. Facilitators in these areas will arrange sweepstakes in the required groups.

The Open Show Spectacular is now conducted by the Dog of the Year Committee. It gives many of our open show judges an excellent learning opportunity.

In April 2015, the Conformation Judges Committee will begin the first of the "Member Education Lectures". These evenings are for the information of all Dogs Queensland members. We hope it will help exhibitors understand what judges look for, help them groom and prepare their dogs, Basic First Aid for dogs etc. Detailed information will be forwarded to members early in the 2015.

Special thanks must go to Kaye McGhie for her valuable assistance in the preparation of this lecture series. I have had the pleasure of working with a great team. Thank you for your time and your commitment in ensuring our trainee judges are given every opportunity to be successful judges.

Obedience:

Our new format of Judges training at Durack and local SEQ club grounds continues to be successful. I would like to thank the members who have attended to support our trainee Judges.

Many thanks must also go to Bob Bruce from Mackay and Glen Best from Cairns for their support in the distance education for our Judges in the central and north Queensland areas.

The Committee has successfully conducted 'Refresher Training' for Obedience Judges throughout Queensland. The ANKC National Obedience and Rally O Committee conference will be held in March 2015 in preparation for a national rule change in 2016. My role will be to coordinate "rule change seminars" for all ANKC Judges in Queensland during the late part of 2015.

We have been approved to conduct a National Trial for Obedience and Rally O in 2015. The Committee has been fundraising very hard to ensure a very successful event.

Tracking and Track and Search:

We have been successful in conducting Judges training in Queensland by using mentoring systems and utilising the senior tracking Judges whilst performing their judging commitments in central and north Queensland.

Tracking and Track & Search faced trying times in 2014 with the continuing drought causing problems with sourcing venues for trials. Many of our regular landowners are suffering badly from these dry conditions and it was not feasible to put any more load on their resources. Also, some regular venues have been sold recently and the various clubs are in negotiations with the new owners concerning the continuing use of these properties.

Agility:

Congratulations to the Agility Subcommittee and all involved for the most successful National Trial held at Durack in June. Some say, the best Nationals ever held in Australia. It was attended by over 500 competitors from all over Australia and New Zealand. These competitors completed over 6000 runs over the 5 days. The event received high profile media coverage and Durack experienced many interested visitors.

Several years of fundraising events provided a healthy bank balance to conduct this successful event. The Sub committee funded new equipment of international standard which has subsequently been made available on permanent loan to five local clubs who provided support in the form of balance of equipment and stewards for the event.

Thanks also to the Board and all other Committees for their support and assistance and the facilities to ensure the successful National. Judges training has been redesigned and will be trialled in 2015.

Rally Obedience

As there is a rule review meeting in March for Rally O, we can expect to see some changes and therefore I will be coordinating Judges Training Seminars accordingly in late 2015 throughout Queensland.

Judges training continues combined with Obedience Judges training.

The Subcommittee have held successful fundraiser trials in preparation for the Inaugural National Trial in June 2015.

Rally O has proved to be very popular with the general public both at the Spectacular and with the EKKA as an official Rally O Trial for the first time this year.

Herding:

The new Subcommittee has been proactive in setting guidelines for competitors and clubs. They have developed criteria for Herding Judges. This can be viewed on the Dogs Queensland Website. Judges training scheme is being planned and developed. Judges training should commence in 2015.

A Judges' refresher seminar was conducted this year for the explanation of the rule change for 2014.

Endurance:

Criteria have been developed for Judges training. Prospective applicants can view the criteria on the Dogs Queensland website.

Dances with Dogs:

2014 saw some exciting developments in Dances With Dogs. Queensland hosted its first State Dances With Dogs competition with two visiting International Judges from England and a third Judge from Western Australia. As a follow on from this Queensland will be hosting the Inaugural National Dances with Dogs competition at Durack in June 2015. We have many sponsors on board to ensure this is a very special event.

Dances With Dogs continues on a firm footing and it was very pleasing to see some new competitors in the ring this year. Dances With Dogs Judges attended three Judges Training Sessions during the year which contributes to the great atmosphere in the ring between the judges themselves and also with the competitors

Lure Coursing:

After many years of demonstrations at Durack and other places in Australia, the ANKC has sanctioned this new discipline. In 2015 we will see competitions being conducted at Durack.

As reported last year, the Canine Health and Welfare Committee developed a mission statement.

The Dogs Queensland Canine Health and Welfare Committee (CHWC) promotes the health and welfare of pedigree dogs through education, encouragement of research, breed improvement schemes and responsible breeding practices to ensure that dogs owned and bred by members live healthy, happy lives with caring and informed owners.

The role of the CHWC is to provide advice to the Board of Directors of Dogs Queensland on:

- Current Scientific Knowledge of and Research into Canine Health and Welfare
- Appropriate Codes of Practice for Members
- Appropriate Breed Improvement (and Accreditation) Schemes

and to promote and conduct seminars and other educational opportunities for members and the public. Education encompasses breeding, raising and caring for dogs at all stages of their life and includes health and physical and behavioural wellbeing.

In keeping with this, the Committee determined that it would hold seminars for breeders and we have worked with the Dogs Queensland Marketing Manager, Helen Mackie to organise the first of which will be held in March. Two highly respected speakers have been invited to speak on topics sure to interest all breeders. Helen's experience in the area has been invaluable and members are assured of a great evening.

Several members of the current Committee are veterinarians and feel strongly that closer ties must be forged between the breeding and veterinary communities. To this end a seminar has been organised for veterinarians, utilising the same speakers. This will have several benefits for Dogs Queensland and members. Veterinarians and their staff will see the excellent facilities we have at Durack and will be informed about the efforts that committed breeders are making to produce healthy stock.

With the assistance of the Marketing Manager, the Health and Welfare Committee hopes to organise regular seminars for both members and veterinarians.

The Chair of the Health Committee attended the National Health Committee meeting in 2014. A National Health Database has been developed and is being trialled this year with results from the national ANKC/AVA Hip Dysplasia scheme. Once these have been entered it is planned to begin entry of genetic test results and finally ACES as eye results are the most complex. It is planned to add additional tests as they become available.

The Health and Welfare Committee will keep the Board and members regularly updated on the progress of this exciting initiative.

2104 was the first year where shows were held in all zones.

Commencing with zone 1 the first 3 shows in April, June and August we contracted Queensland judges. Zone 2 held a triple header in September with a Hawaiian theme, which saw many exhibitors getting into the fun including dressing up camp sites. 3 New Zealand judges were well received although the entry was a little smaller than hoped. A reasonable profit was made in this zone this year allowing the Board to authorise the purchase of shade gazebos for Rockhampton Kennel Club as thanks for their assistance in holding this event.

In 2014 the Event Managers and Stewards Committee continued to provide training for Conformation Ring Stewards, Writers, Show Managers and Show Secretaries. This year the training was presented to 65 members across Queensland in Durack, Beerwah, Gladstone, Townsville and Cairns. As all members of the Committee reside in South East Queensland, the cost of travelling throughout the state to provide training was becoming a concern for the Board, so it has been decided to revert back to having Trainers in Zones 2 and 3. These Trainers will be provided with the current training packages being delivered and will be monitored and assisted to ensure consistency of delivery throughout the state.

Mid-year, the Board of Directors decided that all Show Managers attend an Accreditation refresher every two years, to ensure they are current with the Rules and paperwork pertaining to conformation events. These refresher courses will commence in 2015.

As 2014 draws to a close, it is interesting to look back at what has been achieved during that period. The MPRM Committee is a small but active Committee, and throughout the year and has achieved many things. The protection of an organisation's intellectual property is paramount. The brand 'Dogs Queensland' and CCC(Q) Ltd are now protected trademarks, and cannot be used by any other parties without prior consent of Dogs Queensland. Additionally, copyright for the design has now been assigned from the original designer. This intellectual property is now fully protected.

There were a number of significant events throughout the year. Promotional activity was increased during the June – August periods. Radio advertising promoted and supported 3 major events. The National Agility Trials achieved television news coverage, the EKKA stand was well attended by the public and the All Dogs Sports Spectacular saw many families arrive at Durack and demonstrate interest in our sporting activities.

Dogs Queensland was also represented at numerous external events, such as The Million Paws Walk at Logan, The Gold Coast Pet Expo and the PetBarn Fun Weekend, which raised the profile of Dogs Queensland providing the opportunity to promote responsible dog ownership and the advantages of owning purebred dogs. Dogs Queensland now has a fully equipped and branded trailer to participate in public events, which will serve to increase the Dogs Queensland presence in the marketplace.

The Committee extended support to the Dog/Puppy of the Year Committee, assisting with the preparation of promotional literature, and securing significant additional sponsorship.

An agreement is now in place to have a large billboard erected at the Durack facility. The signage company lease the site from Dogs Queensland, and the leasing arrangements are revenue producing. As part of the agreement, we have secured 4 weeks free advertising space on an annual basis to promote Dogs Queensland events. The Committee secured an ongoing and working relationship with Ronald McDonald House Charities and Delta Therapy Dogs. We have now had our first joint media release with Make A Wish Australia. Aligning ourselves with high profile organisations assists Dogs Queensland to raise its profile in the public arena.

The Dogs Queensland magazine 'Dog World' underwent a significant makeover, with the skills of our new and very talented graphic Designer, Michael. Michael has done a wonderful job to move the magazine into a publication which is a delight to read. Again, there are many tireless workers behind the production of the magazine, organising advertising, sourcing articles, preparing the schedules and proof reading. A magazine which is content heavy, published 12 times per year, requires enormous effort from many people. Well done, all those involved.

Working with the Health and Welfare Committee, we are developing our first Professional seminars, specifically designed for Breeders and Veterinarians. Two high profile presenters will present the results of leading edge research. Professional seminars provide the opportunity to promote Dogs Queensland to an entirely new (and related) market. Two new sponsors have been secured to cover the significant cost items of the event.

The first year of a 3 year sponsorship arrangement with Royal Canin has been completed, with the sponsor expressing delight at the outcome of the first year of sponsorship. A new major sponsor Shopping Lane also came on Board in 2014, and supported a number of significant events, namely the EKKA and Dog/Puppy of the Year. I am very happy to be presenting a report to members about the work of this Committee over the last year. With incorporation of the CCCQ Ltd achieved more than 2 years ago it seemed to me that a key priority for the new Board was the implementation of planning processes, both short term and long term, and involving the wider membership. Although our 20 acre facility at Durack is a cornerstone to our Queensland dog world and our asset base, it was important that the planning process have a wider vision.

It was also important that planning outcomes not be dictated by the Board with a “top down” approach. This was also the vision of the Board and the planning processes were driven by the members with facilitation by the consultant, Mr Howard Nielsen.

Mr Howard Nielsen conducted three rounds of workshops throughout Queensland with a total of 450 members in attendance. A total of 800 ‘ideas’ were presented by members and 26 regional workshops conducted. These workshops were conducted in Cairns, Townsville, Mackay, Rockhampton, Gladstone, Bundaberg, Maryborough, Hervey Bay, Nanango, Caboolture, Toowoomba and Brisbane. In addition and importantly, the process also involved sessions with Dogs Queensland employees and contractors.

Mr Howard Nielsen conducted ten meetings with the Board and various Committees. All in all it has been a very dynamic year stimulating much discussion and thought processes on the part of you, the members. And that is what effective planning processes are all about.

By the time you read this report the Dogs Queensland Strategic Plan 2015-2019 will have been published. It makes it clear that we are ‘purely for dogs’ and provides a framework for the ongoing operations of our wonderful dog world, setting priorities and achievable outcomes by way of stated strategies. But like any useful planning document it needs to evolve in response to changing circumstances and basically be a living document. This will involve at least an annual review of where we are at as an organisation and a consequential review of our operational plans and overall priorities. This plan will drive some exciting developments in our dog world over the next few years.

I would like to take this opportunity to thank Mr Howard Nielsen and his support people for the professional and responsive work undertaken in this process. I would also like to acknowledge the fact that Mr Nielsen donated many additional hours of his time to this project and for that I thank him. I would also like to thank the Strategic Planning Committee members and in particular, Mrs Sandy Mundt, Mr Lionel Blumel and Mrs Patrice Johansen for their dedication and important insights. And finally, I would like to thank the Dogs Queensland Board and the Secretary for having the vision to support and progress this initiative.

I look forward to having a continued involvement with Dogs Queensland planning processes.

Notes to the Financial Statements for the year ended 31 December 2014

Note 1: The Company

The Canine Control Council (Queensland) Ltd (ABN 45 160 285 192) is an incorporated company Limited by guarantee.

Note 2: Statement of significant accounting policies

Basis of preparation

Canine Control Council (Queensland) Ltd applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 2010-2 Amendments to Australian Accounting Standards arising from Disclosure Requirements.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The company is a not-for-profit entity for the financial reporting purposes under the Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial statements except for the cash flow information, have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts provided in the financial statements have been rounded to the nearest dollar.

Accounting Policies

(a) Revenue recognition

Revenue is recognised in the year it is earned.

Interest revenue is recognised as it accrues.

Other revenue includes income from committees of the company, affiliated organisations, donations and sponsorship

and is recognised on an accrual basis. All revenue is stated at the net of the amount of goods and services tax (GST).

(b) Unearned Revenue – Note 12

Includes Membership, Affiliation, Advertising and other fees paid to the company. These fees are initially recognised as unearned revenue and are progressively recognised as income over the period to which they relate. The unearned portion of these fees at 31 December is included in the account unearned revenue.

(c) Income tax

No provision for income tax has been raised as the entity is non assessable for tax under the provisions of the Income Tax Assessment.

(d) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition or as part of an item of expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities, which are recoverable from, or payable to, the ATO are classified as operating cash flows.

(e) Receivables – Note 7

Certain trade debtors' accounts specify a specific due date and those accounts are payable on that date. Other debtors which have no specific due date for payment are normally settled within 30 days. The collectability of debts is assessed at balance date and provision is made for any doubtful accounts.

(f) Investments – Note 8

Bank short term deposits (*current assets*)

The bank term deposits are shown at cost. Interest is accrued at the contracted rate and included in "other debtors".

(g) Inventories - Note 9

Inventories are carried at the lower of cost and net realisable value. Items which are considered consumables are expensed in the year of purchase. Inventories are primarily printing material sold to breeders, members and club organisations.

(h) Property, plant and equipment - Note 10

Acquisition

Items of property, plant and equipment are recorded at cost.

Depreciation and amortisation

Items of property, plant and equipment including buildings and ground improvements are depreciated using the diminishing-value method and prime cost method over their estimated useful lives.

The depreciation rates used for each class of asset are as follows:

Durack

- Buildings and ground improvements 2-20%
- Plant and equipment 5 - 50%

Office

- Building 2%
- Plant and equipment 10-100%
- Refurbishments 20%

(i) Payables - Note 11

Liabilities are recognised for amounts to be paid in the future for goods or services received, whether or not billed to the Company. Trade accounts payable are normally settled within 30 days.

(j) Employee Entitlements - Note 13

The provisions for Short Term Employee Benefits to wages, salaries and annual leave represent the amount which the Company has a present obligation to pay resulting from employees' services provided up to the balance date. The provisions have been calculated at amounts based on current wage and salary rates.

(k) Other Long Term Employee Benefit - Note 13

Provision with respect to long service leave is made on the basis of the total nominal entitlement of permanent employees from 5 years after commencement of employment. The provision has been calculated at amounts based on current wage and salary rates.

The Board is satisfied that this estimate reliably represents the present value of future cash flows to be made by the Company in respect to services provided by employees up to the reporting date.

The company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

(l) Superannuation plans

The Company contributes to several specific superannuation plans. Contributions are charged to the income statement as incurred.

(m) Financial Instruments - Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the company commits itself to either purchase or sell the asset (ie trade date accounting is adopted)

Classification and subsequent measurement

Financial instruments are subsequently measured at fair value, amortised cost using the effective interest method, or cost. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as the amount at which the financial asset or financial liability is measured at initial recognition less principal repayments and any reduction for impairment, and adjusted for any cumulative amortisation of the difference between that initial amount and the maturity amount calculated using the *effective interest method*.

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying amount with a consequential recognition of an income or expense item in profit or loss.

Note 2: Statement of significant accounting policies (continued)

(i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

(ii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the company's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

Impairment

At the end of each reporting period, the company assesses whether there is objective evidence that a financial asset has been impaired. A financial asset or a group of financial assets will be deemed to be impaired if, and only if, there is objective evidence of impairment as a result of the occurrence of one or more events (a "loss event"), which has an impact on the estimated future cash flows of the financial asset(s).

In the case of financial assets carried at amortised cost, loss events may include: indications that the debtors, or a group of debtors, are experiencing significant financial difficulty, default or delinquency in interest or principal payments; indications that they will enter into bankruptcy or other financial reorganisation; and changes in arrears or economic conditions that correlate with defaults.

Recoverable amount

The carrying amounts of non-current assets valued on the cost basis are reviewed to determine whether they are in excess of their recoverable amount at balance date. If the carrying amount of a non-current asset exceeds the recoverable amount, the asset is written down to the lower amount.

The write down is expensed in the reporting period in which it occurs. In assessing recoverable amounts the relevant cash flows have been discounted to their present value.

For financial assets carried at amortised cost (including loans and receivables), a separate allowance account is used to reduce the carrying amount of financial assets impaired by credit losses. After having undertaken all possible measures of recovery, if the management establishes that the carrying amount cannot be

recovered by any means, at that point the written-off amounts are charged to the allowance account or the carrying amount of impaired financial assets is reduced directly if no impairment amount was previously recognised in the allowance accounts.

When the terms of financial assets that would otherwise have been past due or impaired have been renegotiated, the company recognises the impairment for such financial assets by taking into account the original terms as if the terms have not been discounted to their present value.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expire or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset.

Financial liabilities are derecognised where the related obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

(n) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes for the current financial year.

(o) Critical Accounting Estimates and Judgements

The directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the company.

(p) New Accounting Standards for Application in Future Periods

The AASB has issued new, revised and amended standards and interpretations that have Mandatory application dates for future reporting periods, which the company has not adopted early. The application of those standards to the company has been reviewed and it has been assessed that they will not have any material impact to the company's financial statements.

The company does not anticipate early adoption of any of the reporting requirements included in these standards and does not expect these requirements to have any material effect on the company's financial statements.




