Chairperson's Report

On behalf of the Board of Directors, I submit the following report for members' consideration upon the activities of Canine Control Council (QLD) Ltd trading as Dogs Queensland, during the year ended 31 December 2015.

Financial Results

The audited financial statements for the last calendar year, along with the unqualified certification of the accounts by the independent auditor, show that financially our organisation is in good shape, with a surplus of \$95,077 by the end of the year. This figure is down by \$24,689 from the prior year, and overall is a very satisfactory outcome in terms of our budget expectations, and very pleasing in terms of our strategic efforts. It is not easy to maintain profit to budgeted levels given the many variables that effect final results. Litter Registration income increased by \$43,266 whilst the income from the Members' Seminars throughout the year created extra revenue. Professional and Legal costs decreased by \$32,224 and Magazine expenditure decreased by \$12,918. The Board of Directors and our newly established Audit and Finance Committee will continue to examine strategies in an endeavour to supplement our income and reduce our expenditure into the future.

I would like to thank our General Manager, Mr Rob Harrison, our newly appointed accountant Mr Umesh Prasad and retiring accountant Mr Wayne Chapple, for their great personal contribution to maintenance of the profit level above budget throughout the financial year.

The Board of Directors rely heavily on the activities of a number of Committees and Working Parties, to carry out delegated responsibilities to ease the workload which would otherwise choke the monthly Board Agenda. To the Chairperson's and members of all our Committees and Working Parties, I extend a sincere vote of thanks of both the Board and the membership.

Board of Directors

As part of this report, we should farewell retiring Directors, and this year we say farewell to Helen Acworth and Robyn Nicholson. I would like to thank both these ladies for their service and dedication over the previous two years, and wish them all the best with their future endeavours.

Our newly appointed Directors during the calendar year were Mr Timothy Thomas and Mr Craig Pettett. We wish both Timothy and Craig a successful tenure, and look forward to their further contributions.

Durack Grounds and Camping

Much of this year has been spent progressing the continued improvements at our Durack grounds and continuing the application for our camping on these grounds. The Grounds Committee and Camping Working Party have worked tirelessly for the benefit of all members to see these projects finalised in the most timely and efficient manner. Our camping application is now in the final stages of public advertisement, and we expect that the entire project will soon come to an end. Continued improvements and development of Durack have been planned for, and members will be kept up to date regarding these projects as they eventuate.

Government Liaison and Proposed Puppy Farming Legislation

One of the major topics of discussion and work throughout this year, would have to be the proposed Queensland Government legalisation in relation to puppy farming. Various discussions and meetings between Dogs Queensland and the Queensland Government have been undertaken during the year, in order to determine the full extent of the proposed legislation, and also to negotiate an exemption for Dogs Queensland members from provisions of the legislation. To date Dogs Queensland are yet to see the draft legislation, and nothing has been presented to State Parliament at the date of this report. We will continue to lobby the Government on this matter, and seek the best possible outcome for our members.

In order to further assist on this matter, the Board agreed to engage the services of a highly recommended Public Relations firm. PPR Australia, who have been engaged to undertake the following core duties in order to assist Dogs Queensland:

- Increase awareness of Dogs Queensland
- Position Dogs Queensland as the authority on dog breeding in Queensland
- Make Dogs Queensland the 'go to' voice for comment on anything related to dogs in Queensland.

The engagement of PPR will benefit Dogs Queensland in many ways, and I am very excited about the end results to be achieved. This is a positive step forward for our organisation, and one which will bring us into the spotlight on many more platforms, and establish Dogs Queensland as the organisation to contact for any matters relating to pure bred dogs.

Events

Throughout each year, Dogs Queensland has a number of events which are used in the promotion of our hobby and our organisation. One of the major events was the All Dogs Sports Spectacular, which generated a huge public interest and was up on overall attendance from the previous year. It truly is a wonderful sight to walk around and see all the different types of activities our hobby is about from Confirmation Show, to Agility, to Dances with Dogs. This broad spectrum view of our hobby was extremely well received by the public, and the word of mouth we have received is worth its weight in gold. Once again we were able to work closely with Ronald McDonald House and Delta Therapy Dogs, and we hope to continue this important partnership in the years to come.

Events continued

In August each year we are part of the Brisbane Royal Show (EKKA) with our Dogs Queensland Promotion Stand. My sincere thanks must go to Helen Mackie and the dedicated workers who ran this stand day after day. This year's stand was beyond expectation, with our show bags selling at an unbelievably rapid rate, and voted as one of the 'best value show bags' at the Show by the public in the Courier Mail.

This year also marked the first ever 'Directors' Show' for Dogs Queensland. This Show was to allow the Directors to give back something to the membership. Each Director donated towards the trophies for the event, and also donated their time by working at the Show. All profits from the event will go back into the Durack Committee for further development of various projects across our diverse State. Planning is already underway for this year's Directors' Show, and the Board hope it will be bigger and better than last year, and also take a much more social approach.

In November, we also saw the first 'Members Forum' held at Durack. The aim of the forums was to allow members to have contact with a group of Directors, to express their thoughts and/or concerns directly. Whilst the first event was not overly well attended, the matters raised presented some excellent points for Board consideration. The Members Forums will continue over this year, with the Board endeavouring to hold at least four a year.

Throughout the year the Conformation Judges Committee, headed by Shaneen Bendixen and Ian Rasmussen, put on the very well received Members' Seminars. These were well attended with up to 100 people coming along to the Durack Function Room. Some of the topics covered included Dog Nutrition, Canine First Aid, Anatomy, Movement and Genetics.

As always Chair Barb Murfet and the Dogs Queensland QDS Committee put on some ground breaking events in 2015 including the State and National Obedience and Rally O Trials as well as the State and inaugural National Dances with Dogs Trial. In my mind it is certainly no coincidence that National Events come to this State on an increasingly regular basis.

I congratulate all the organising Committees of these very successful events. Each one is a great achievement and a showcase for Dogs Queensland.

Into the future

We are now into our third year of our association with our major sponsor, Royal Canin. Their product sponsorship for our events is exceptional, and very much appreciated. On behalf of the Board, the membership and the exhibitors, I thank Royal Canin most sincerely for their continued support of Dogs Queensland.

2016 is poised to be a monumental year for Dogs Queensland. We will undertake many new initiatives to better establish our organisation, our brand and who we are.

Government and Agency Liaison Officer Report

Annual Report (year ending December 2015)

The 2015 agenda in relation to our State Government activities was set very much by events that occurred in the latter half of 2014. In August of 2014, the then Opposition Leader Annastasia Palaszczuk used the Brisbane Royal as a platform to resurrect the so called Puppy Farm Reform strategy. The Opposition Leader offered bipartisan support for the Legislation and invited Premier Newman to revitalise the Puppy Farm Reform strategy – this call went unheeded. For all of the three years of LNP reign, the reform strategy sat in moth balls.

Members will recall that the concept of controlling and eradicating unscrupulous puppy farmers via Legislation began in November 2010 where key stakeholders were invited to attend a meeting convened by the then Primary Industries Minister Hon Tim Mulherrin. A considerable amount of work had been done by the stakeholder group in the 12 months following that initial meeting but as political fate would have it, the proposed Legislation never made it to first base due to the landslide victory recorded by the LNP at the March 2012 State election.

Campbell Newman and his LNP team won that election and Queensland Labor suffered one of the worst defeats of a State Government since Federation, and the worst defeat of a sitting Government in Queensland history. From 51 seats in 2009, it was reduced to only seven seats, suffering a swing of 15.6 percentage points. The LNP won a majority for the first time in its history, jumping from 34 seats to 78 seats to win the largest majority Government in Queensland history.

During that period of Liberal Government, three requests by Dogs Queensland to meet with the new Minister for Agriculture went unanswered – that attitude was widely reported as being the modus operandi and in many ways spelled the eventual undoing of the Newman Government at the State Election held on the 31st January 2015.

In mid December of 2014, Opposition Leader Palaszczuk utilised our Dogs Queensland Sports Grounds at Durack to announce that the Puppy Farm Reform Strategy would in fact become Labor Policy at the upcoming State election. As history records, Labor won that election with 44 seats (one short of a majority) and from that point onwards, the strategy to reform puppy farming in Queensland became to primary focus of Dogs Queensland.

A number of guarantees had been extended to Dogs Queensland by key decision makers within the Premier's Department and those guarantees were reconfirmed at a meeting between senior policy advisors to the Premier and the Agriculture Minister (Hon Bill Byrne) and our Dogs Queensland General Manager and Government Liaison Officer. Our organisation was offered an exemption from the Legislation in recognition of our "Peak Industry Body" status and a further guarantee that the new Legislation would not affect any of our members owning less than 20 dogs.

Furthermore, we were confident that the Government may take up our proposal that Dogs Queensland design and maintain a statewide dog breeder registration scheme – that is what our organisation does best after all.

Members may recall that during early September 2015, an online survey was conducted by Biosecurity Queensland. That survey was designed to determine the extent to which Queenslanders understood the problem of Puppy Farms. The survey also tried to ascertain what Queenslanders felt were some of the solutions to solving the issue of puppy farming in our State. On 7th September 2015 (the day after the survey closed), I reported to the Dogs Queensland Executive team that just 73 responses could be definitely attributed to Dogs Queensland members based on the responses to question 18. I have since learned that only 102 responses (including hard copy postal responses) could be attributed to our members.

Annual Report (year ending December 2015) continued

With a total of 8,300 responses being recorded to the online survey, the Dogs Queensland share of voice was just 1.2%.

A cabinet reshuffle in December of 2015 means that we have yet another new Agriculture Minister to build a relationship with – our new Minister is the Hon Leanne Donaldson and urgent meetings will be scheduled during February 2016 to raise our concerns with the implications of the proposed Puppy Farm Legislation in its present format.

We may well need to call upon the support of our members to demonstrate to the Minister what impact could be expected if things remain unchanged – I really do hope that members will recognise the importance of getting behind our Directors and lend a hand when called upon to do so.

During 2015, 15 meetings of Directors were held. Attendances by each Director were as follows:



Key Performance Measures

The Company measures its own performance through the use of both quantitative and qualitative benchmarks. The benchmarks are used by the directors to assess the financial sustainability of the Company and whether the Company's short-term and long-term objectives are being achieved. The Key Performance Measures used are Renewing Full Single Members 3,483 (2014 - 3,480), Full Joint Members 1,244 (2014 - 1,262), New Members 833 (2014 - 796), Litter Registrations 15,553 (2014 - 14,954), Renewing Prefixes 3,116 (2014 - 3,078), New Prefixes 365 (2014 - 350) and Transfers of Dogs 3,588 (2014 - 3,701).

Members Guarantee

Canine Control Council (Queensland) Limited is a company limited by guarantee. In the event of, and for the purpose of winding up of the company, the amount capable of being called up from each member and any person or association who ceased to be a member in the period prior to the winding up, is limited to \$1. The number of Members at the end of 2014 was 6,513. (2014 – 6,652)

Operating Results

The consolidated profit of the economic entity for the financial year amounted to \$95,077.

Subsequent Events

No matter or circumstance has arisen since the end of the financial year, which has significantly affected or may significantly affect:

- (a) the Company's operations,
- (b) the result of those operations,
- (c) the Company's state of affairs.

Dividends

The Company is prohibited under its constitution from payment of Dividends to its members.

Indemnification Of Company Officers and Auditors

During the financial year, the Company paid a premium in respect of a contract insuring the Directors of the Company (as named above), the Company Secretary and all Executive Officers of the Company and of any related Body Corporate against liability incurred as such a Director, Company Secretary or Executive Officer to the extent permitted by the Corporations Law.

The Company has not otherwise, during or since the end of the financial year, indemnified or agreed to indemnify an Officer or Auditor of the Company or of any related Body Corporate against a liability incurred as such an Officer or Auditor.

Directors' Benefits

Within the financial year, no Director of the Company has received or become entitled to receive any benefit by reason of a contract made by the Company or a related corporation with the Director or with a firm of which he is a member or with a Company in which he has a substantial financial interest.

Objectives:

The objectives of the Company shall be:

- 1. to be the governing canine body for the State;
- 2. to maintain membership of the National Canine Body and to enhance and promote its standing within that body;
- 3. to promote and encourage the development and responsible breeding of healthy purebred registered dogs throughout the State;
- 4. to promote and encourage the recreation, sport, exhibition and training of the CCCQ Ltd registered dogs throughout the State;
- 5. to promote and encourage the training of all dogs throughout the State;
- 6. to promote the development and improvement of the health and welfare of purebred registered dogs throughout the State;
- 7. to promote and encourage membership of the CCCQ Ltd with its attendant advantages and privileges;
- 8. to promote and develop policies and regulations that shall be used as a quality benchmark for dog breed standards ensuring that the welfare and health of dogs remains paramount;
- 9. to promote, develop and maintain close working relationships with all levels of Government (Commonwealth, State and Local) to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
- 10. to promote, develop and maintain close working relationships with other organisational bodies and other stakeholder groups with similar objectives to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
- 11. to promote and encourage public interest and participation in the CCCQ Ltd sanctioned exhibitions and events;
- 12. to promote and encourage scientific research into canine related health issues both in Queensland and interstate;

Objectives continued

- 1. to act as the control of the CCCQ Ltd registered dog related activities throughout Queensland including:
 - (j) to administer Rules for the conduct and regulation of all the CCCQ Ltd exhibitions and events;
 - (ii) to keep a register of purebred dogs and their ownership;
 - (iii) to keep a register of all breeder prefixes;
 - (iv) to administer regulations relating to purebred dogs;
 - (v) to grant or withhold affiliation to bodies with similar objectives referred to as affiliated bodies;
 - (yi) to administer certificates, awards, championships and titles;
 - (vii) to assist in the prevention of illegal or dishonest practices in relation to dog related activities in Queensland; and
 - (viii) to facilitate the operation of independent registers for Non-Conformation activities including registers for non-purebred dogs;
- 2. to promote and encourage development of knowledge and skills relating to canine activities.

To achieve these objectives, the entity has adopted the following strategies:

- Attract and retain qualified staff to administer the business of the entity and provide member services which meet consistent standards of best practice as compared to similar entities and this is evidenced by low staff turnover
- Attract and retain volunteers from within the membership who are committed to the entity's objectives
- Both staff and volunteers will continue to work towards both the entity's short and long term objectives
- Continue to keep open the lines of communication with all Government bodies on all aspects of purebred dogs
- Collect, verify and publish information relating to purebred dogs and the breeding and exhibition of purebred dogs

The Grounds Committee has again worked tirelessly in 2015. The main Committee now has a number of working Subcommittees that has helped greatly from an efficiency point of view. The Grounds Committee now encompasses a regional Amenities Zone 2 and Zone 3 Subcommittee, Chaired by Craig Pettett that will assist Clubs in those areas with projects, as well as an Amenities Zone 1 Committee responsible for the funding at Duarck. The Committee continues to cater at many Shows to earn money towards completing many projects at the Durack Grounds.

These projects include;

- Provision of brand new stove in the kitchen
- Continuing upgrade of all BBQ areas
- Purchase of storage container

The main focus of the Grounds Committee was obviously the completion of the next Camping stage at Durack, in other words the 'Development Application for Extensions to Existing Club' (ancillary caravans and tents). It is hoped by the time you read this report our Grounds will be open for Caravans and RV's that will consolidate the future of Shows at Durack.

Amenities Zone 2 and 3 Subcommittee

In 2015, Regional Amenities fund raising Shows were operated under the existing arrangements put in place by the former Amenities Committee.

Robyn Nicholson had already worked extremely hard, tirelessly in fact, to secure international judges for these events and undertake a monumental amount of work in the administration of these Shows which were well patronised by members. I would like to thank all members of this Subcommittee for their input and their commitment during 2015.

Unfortunately, due to some unforeseen and uncontrollable circumstances, including judges being unavailable for appointments, there were some additional costs incurred which impacted on the overall funds raised from these Shows – this is always a risk in the regional areas where entry levels are not as high and are impacted more significantly by such events than they would be in the metropolitan areas.

The Subcommittee organising these Shows for 2016 is firmly focussed on the core objective of raising funds for regional purposes. This funding enables infrastructure and development activities to be undertaken in regional areas.

In 2015, Zone 3 benefitted from a grant to assist in the establishment of a new amenities block at the Woodstock grounds near Townsville where major developments and improvements are underway, while several Zone 2 clubs had lodged applications for improvements to their facilities.

A Trial is being conducted in April 2016, partnering an Amenities Show with the Mt Perry Agricultural Society Show and we hope that members support this, not only to raise funds for the benefit of the regional areas, but also to establish a template for the future where we can work with Agricultural Society Shows to further promote our hobby and our organisation to the public.

Feedback on these shows and the model for presenting them to be as successful as possible and raise money for regional areas is always welcome from members.

Strategic Planning is probably one of the most difficult concepts to understand, gain engagement with, and to execute in any organisation. Dogs Queensland, in 2015, embarked on this journey towards a desired future state following an extensive member consultation process expertly facilitated by Howard Neilsen.

The important part to understand is that Dogs Queensland's Strategic Plan 2015-2019 is a journey that has only just begun for the organisation. The plan presented to members in March 2015 is our starting point and is in no way an inflexible document to gather dust on the shelf. There will be many changes over time as priorities, resources and our environment continue to change.

We have now transitioned from the development phase to the delivery phase, and the Strategic Planning Committee is working closely with Dogs Queensland Committees and Stakeholders to monitor and measure our progress towards our objectives.

Some of the Committee's achievements in 2015 have included:

- Developing the stakeholder list for Strategic Plan Deliverables; and
- Developing and implementing a reporting framework to commence quarterly updates the first one was released for the period ending 30 September 2015

This may not seem like a lot, but with over 250 deliverables in the Dogs Queensland Strategic Plan, this is a massive amount of coordination and investigative work for a Committee of volunteers. Organisations of our size typically have a team of full-time analysts to manage a Strategic Plan.

Notes to the Financial Statements for the year ended 31 December 2015

Note 1: The Company

The Canine Control Council (Queensland) Ltd (ABN 45 160 285 192) is an incorporated Company Limited by Guarantee.

Note 2: Statement of significant accounting policies

Basis of preparation

Canine Control Council (Queensland) Ltd applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 2010-2 Amendments to Australian Accounting Standards arising from Disclosure Requirements.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The Company is a not-for-profit entity for the financial reporting purposes under the Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs modified, where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts provided in the financial statements have been rounded to the nearest dollar.

Accounting Policies

(a) Revenue recognition

Revenue is recognised in the year it is earned. Interest revenue is recognised as it accrues. Other revenue includes income from Committees of the Company, affiliated organisations, donations and sponsorship and is recognised on an accrual basis. All revenue is stated at the net of the amount of goods and services tax (GST).

(b) Unearned Revenue - Note 12

Includes Membership, Affiliation, Advertising and other fees paid to the Company. These fees are initially recognised as unearned revenue and are progressively recognised as income over the period to which they relate. The unearned portion of these fees at 31 December is included in the account 'unearned revenue'.

(c) Income tax

No provision for income tax has been raised as the entity is non assessable for tax under the provisions of the Income Tax Assessment.

(d) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition or as part of an item of expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities, which are recoverable from, or payable to, the ATO are classified as operating cash flows.

(e) Receivables - Note 7

Certain trade debtors' accounts specify a specific due date and those accounts are payable on that date. Other debtors which have no specific due date for payment are normally settled within 30 days. The collectability of debts is assessed at balance date and provision is made for any doubtful accounts.

(f) Investments - Note 8

Bank short term deposits (current assets)

The bank term deposits are shown at cost. Interest is accrued at the contracted rate and included in "other debtors".

(g) Inventories - Note 9

Inventories are carried at the lower of cost and net realisable value. Items which are considered consumables are expensed in the year of purchase. Inventories are primarily printing material sold to breeders, members and Club organisations.

(h) Property, plant and equipment - Note 10 Acquisition

Items of property, plant and equipment are recorded at cost.

Depreciation and amortisation

Items of property, plant and equipment including buildings and ground improvements are depreciated using the diminishing-value method and prime cost method over their estimated useful lives.

The depreciation rates used for each class of asset are as follows:

Durack

Buildings and ground improvements 2-20%
Plant and equipment 5 - 50%

Office

Building 2%
Plant and equipment 10-100%
Refurbishments 20%

(i) Payables - Note 11

Liabilities are recognised for amounts to be paid in the future for goods or services received, whether or not billed to the Company. Trade accounts payable are normally settled within 30 days.

(j) Employee Entitlements - Note 13

The provisions for Short Term Employee Benefits to wages, salaries and annual leave represent the amount which the Company has a present obligation to pay resulting from employees' services provided up to the balance date. The provisions have been calculated at amounts based on current wage and salary rates.

(k) Other Long Term Employee Benefit - Note 13

Provision with respect to long service leave is made on the basis of the total nominal entitlement of permanent employees from 5 years after commencement of employment. The provision has been calculated at amounts based on current wage and salary rates. The Board is satisfied that this estimate reliably represents the present value of future cash flows to be made by the Company in respect to services provided by employees up to the reporting date.

The Company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the Company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

(I) Superannuation plans

The Company contributes to several specific superannuation plans. Contributions are charged to the income statement as incurred.

(m) Financial Instruments - Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Company commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted)

Classification and subsequent measurement

Financial instruments are subsequently measured at fair value, amortised cost using the effective interest method, or cost. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as the amount at which the financial asset or financial liability is measured at initial recognition less principal repayments and any reduction for impairment, and adjusted for any cumulative amortisation of the difference between that initial amount and the maturity amount calculated using the effective interest method.

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying amount with a consequential recognition of an income or expense item in profit or loss.

Note 2: Statement of significant accounting policies (continued)

(i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

(ii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the Company's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

Impairment

At the end of each reporting period, the Company assesses whether there is objective evidence that a financial asset has been impaired. A financial asset or a group of financial assets will be deemed to be impaired if, and only if, there is objective evidence of impairment as a result of the occurrence of one or more events (a "loss event"), which has an impact on the estimated future cash flows of the financial asset(s).

In the case of financial assets carried at amortised cost, loss events may include: indications that the debtors, or a group of debtors, are experiencing significant financial difficulty, default or delinquency in interest or principal payments; indications that they will enter into bankruptcy or other financial reorganisation; and changes in arrears or economic conditions that correlate with defaults.

Recoverable amount

The carrying amounts of non-current assets valued on the cost basis are reviewed to determine whether they are in excess of their recoverable amount at balance date. If the carrying amount of a non-current asset exceeds the recoverable amount, the asset is written down to the lower amount.

The write down is expensed in the reporting period in which it occurs. In assessing recoverable amounts, the relevant cash flows have been discounted to their present value.

For financial assets carried at amortised cost (including loans and receivables), a separate allowance account is used to reduce the carrying amount of financial assets impaired by credit losses. After having undertaken all possible measures of recovery, if the management establishes that the carrying amount cannot be

recovered by any means, at that point the written-off amounts are charged to the allowance account or the carrying amount of impaired financial assets is reduced directly if no impairment amount was previously recognised in the allowance accounts.

When the terms of financial assets that would otherwise have been past due or impaired have been renegotiated, the Company recognises the impairment for such financial assets by taking into account the original terms as if the terms have not been discounted to their present value.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expire or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset.

Financial liabilities are derecognised where the related obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of noncash assets or liabilities assumed, is recognised in profit or loss.

(n) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes for the current financial year.

(o) Critical Accounting Estimates and Judgements

The Directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.

(p) New Accounting Standards for Application in Future Periods

The AASB has issued new, revised and amended standards and interpretations that have Mandatory application dates for future reporting periods, which the company has not adopted early. The application of those standards to the company has been reviewed and it has been assessed that they will not have any material impact to the Company's financial statements.

The Company does not anticipate early adoption of any of the reporting requirements included in these standards and does not expect these requirements to have any material effect on the Company's financial statements.
