### **Chairperson's Report**

On behalf of the Board of Directors, I submit the following report for members' consideration upon the activities of Canine Control Council (QLD) Ltd trading as Dogs Queensland, during the year ended 31 December 2016.

#### **Financial Results**

The audited financial statements for the last calendar year, along with the unqualified certification of the accounts by the independent auditor, show that financially our organisation is in good shape, with a surplus of \$77,486 by the end of the year. This figure is down by \$17,591 from the prior year, and overall is a very satisfactory outcome in terms of our budget expectations, and very pleasing in terms of our strategic efforts. The Board of Directors will continue to examine strategies in an endeavour to supplement our income and reduce our expenditure into the future. I would like to thank our General Manager, Mr Rob Harrison, and our accountant, Mr Umesh Prasad, for their great personal contribution to maintenance of the profit level above budget throughout the financial year.

Without your contributions and dedications, our organisation wouldn't continue to grow from strength to strength. Finally a thank you to Grounds Manager Bob Dorr and assistant Michael Watt. Our Grounds continue to be the envy of every other ANKC Member Body and are always presented in immaculate condition.

The Board of Directors rely heavily on the activities of a number of Committees and Working Parties, to carry out delegated responsibilities to ease the workload which would otherwise consume the monthly Board Agenda. To the Chairpersons and members of all our Committees and Working Parties, I extend a sincere vote of thanks of both the Board and the membership.

#### **Board of Directors**

As part of this report, we should farewell retiring Directors, and this year we say farewell to Sandra Mundt and Lionel Blumel. I would like to thank both these individuals for their service and dedication over the previous four years, and for all the years prior that they contributed their services to the former association of the Canine Control Council (QLD). Both Lionel and Sandra have been long term Board members for our organisation, and we wish them all the best with their future endeavours.

#### **Government Liaison and Proposed Puppy Farming Legislation**

Much of this year has been spent working with the various parties, including the Queensland Government in relation to the Animal Management (Protecting Puppies) and Other Legislation Amendment Act 2016 (Act). Various discussions and meetings between Dogs Queensland and the Queensland Government have been undertaken during the year, in order to determine the full extent of the proposed legislation to continue to negotiate an exemption for Dogs Queensland members from provisions of the legislation, and also to discuss the full extent of becoming an 'approved entity' under the legislation.

The Queensland Government also worked with Dogs Queensland to hold a webinar, and attend one of our scheduled members forums, to discuss the legislation and listen to questions and feedback from Dogs Queensland members. Dogs Queensland will move to make application to become an approved entity, as this is the best way forward for us as an organisation, and for our members to be better protected.

By becoming an approved entity, Dogs Queensland will retain its consultative status with the Department of Agriculture and Fisheries, and will also continue to work alongside other stakeholders on Government working parties tasked with the implementation and strategy development of this legislation. Members will continue to receive information about this matter as it unfolds.

### **Relocation of the Dogs Queensland Office of Durack**

During the year, members were given the chance to have their say on whether they felt the Dogs Queensland office should be relocated from the current Fortitude Valley site out to Durack. The result of this survey showed that an overwhelming response of over 90% wanted the office moved out to our grounds at Durack. The Board has given a commitment that this relocation will happen, and be completed within the first half of the 2017 year. A number of possibilities on how this relocation should take place were considered and evaluated by the Board. In the end, it was decided that the best option was to conduct a retrofit of the current Durack building. Various quotations were sought by the Board, with Future Fitouts being selected as the successful service provider for the refit of the office.

#### **Service Delivery Review**

Dogs Queensland engaged the services of 'Board Matters' to undertake a service delivery review of its operational processes and procedures. This is the first time a review of this nature has been conducted by our organisation. The review document handed down to the Board was accepted, and the implementation of recommendations provided by Board Matters will begin in early 2017. Board Matters will work with Dogs Queensland to design a governance document and a timeline of implementation processes to ensure the transition into the new framework is as smooth and efficient as possible. A change management process has been undertaken with all staff of Dogs Queensland.

### **Durack Grounds and Camping**

Early in 2016, the camping application for Dogs Queensland was finalised and implemented. As most members will know, this was a long process which required months of work, to ensure the provision of the Brisbane City Council were fully met.

Much of this year has been spent progressing the continued improvements at our Durack grounds. The Grounds Committee have worked tirelessly for the benefit of all members to see their undertaken projects finalised in the most timely and efficient manner, and without causing any disruption to events or members. Continued improvements and development of Durack have been planned for, and members will be kept up to date regarding these projects as they eventuate.

#### **Public Relations**

The Board agreed to continue its engagement of services with highly recommended Public Relations firm, PPR Australia. PPR Australia were engaged to undertake the following core duties for Dogs Queensland:

- Increase awareness of Dogs Queensland
- Position Dogs Queensland as the authority on dog breeding in Queensland
- Make Dogs Queensland the 'go to' voice for comment on anything related to dogs in Queensland

During their engagement, PPR have proven to be a valuable asset for Dogs Queensland in many ways, and the profile of our organisation has grown substantially over the last two years. PPR's continued service to Dogs Queensland will strengthen our reputation as the 'go to' organisation for any matters relating to pure bred dogs.

#### **Events**

Throughout each year, Dogs Queensland has a number of events which are used in the promotion of our hobby and our organisation. One of the major events was the All Dogs Sports Spectacular, which generated a huge public interest and was up on overall attendance from the previous year. It truly is a wonderful sight to walk around and see all the different types of activities our hobby is about from Conformation Show, to Agility, to Dances with Dogs. This broad spectrum view of the hobby was extremely well received by the public, and the word of mouth we have received is worth its weight in gold. Once again we were able to work closely with Ronald McDonald House and Delta Therapy Dogs, and we hope to continue this important partnership in the years to come.

In August each year we are part of the Brisbane Royal Show (EKKA) with our Dogs Queensland Promotion Stand. My sincere thanks must go to Helen Mackie and the dedicated workers who ran this stand day after day. This year's stand was again beyond expectation, with our show bags again selling at a rapid rate.

The second ever 'Directors' Show' for Dogs Queensland was also conducted this year. This Show is designed to allow the Directors to give something back to the membership. Each Director donated towards the trophies for the event, and also donated their time by working at the Show. All profits from the event go back into the Durack Committee for further development of various projects across our diverse State. Planning has already begun for the 2017 Directors' Show, and the Board hope it will be bigger and better than last year, and will continue with the very social approach taken during the 2016 event.

In 2016, we saw the continuation of the 'Members Forums' held at Durack. The aim of the forums was to allow members to have contact with a group of Directors, to express their thoughts and/or concerns directly. The matters raised presented some excellent points for Board consideration. The Members Forums will continue over this year, with the Board endeavouring to hold a least four a year.

#### Into the future

We are now into our fourth year of our association with our major sponsor, Royal Canin. Their product sponsorship for our events is exceptional, and very much appreciated. On behalf of the Board, the membership and the exhibitors, I thank Royal Canin most sincerely for their continued support of Dogs Queensland. 2017 is poised to be one of the biggest years ever for Dogs Queensland, with many changes for the better on the horizon. We will undertake many new initiatives to better establish our organisation, our brand and who we are.

### **Government and Agency Liaison Officer Report**

### **Annual Report (year ending December 2016)**

As I prepare this report to members for the year that was 2016 I can't help but be reminded that it is often times the little things that we do (when grouped together) that can have such a huge influence on the big issues we are facing.

Somerset Regional Council can be viewed as a very good example of members doing the lobbying of their elected Councillors whilst supporting the strategy I was following with the Mayor and his full Council. We received the news at the end of 2016 that a public consultation which asked Somerset residents to respond to a proposed local law change designed to allow additional dogs to be kept was well supported with a majority of responses received being in favour of the changes.

This good news was the culmination of 3 years of hard work with many of my appointments with key Somerset decision makers resulting in disappointment. Having said that I have never written off a Local Council just because they have rejected our Breeder Permit Scheme strategy – in my dictionary no means maybe.

Early in the new year I will be setting time aside to work with Somerset Local Law makers to make sure that our members are protected. Whilst we didn't get everything that we asked for it has been agreed that this local law change is just the first step – if the transition to more flexible local laws is successful then I will revisit Somerset in about 12 months time with a proposal that will more closely mirror the schemes that are in place in Logan City and Moreton.

There will be similar submissions made to other local councils during the first quarter of 2017. First of those will be Bundaberg and a lot of good work has already been done to ensure that all of the information that I need to include in my presentation is accurate and timely.

Fraser Coast is also still on my radar but that Council presents a host of very different issues – not the least of which is that Council's introduction of a new local law that requires breeders to provide pre-paid desexing vouchers as part of every puppy sale. Unfortunately this local law was already in force before members alerted me of their concerns. It is not surprising that I have found it very difficult to gain any traction with Fraser Coast Regional Council – their response has been predictable – there was plenty of time for our members residing in the Fraser Coast region to voice their concerns during the consultation period.

I know I have said it before but now more than ever it has become critically important that members (particularly those living in regional areas) to take ownership of their local laws as they affect dogs. Please take the time to glance at the public notices as they appear in the local newspapers / local rag – the earlier members can alert me to local law reviews the more time I have to get our submissions in front of the key decision makers.

Now more than ever before having a kennel license or a breeder permit issued by a Local Council is highly prized – having one of those approvals to keep additional dogs and to breed from those dogs represents the ultimate in protection against whatever the State Govt may introduce by way of a State Breeder Registry.

Let this also serve as a heads up to our members who currently live within a local council boundary that offers licenses or permits as described above – it seems that there are still far too many members who seem to have chosen not to apply for the approvals on offer. I can't imagine why a member would not take full advantage of the opportunity to be fully compliant with local laws – it really does mean that members can live with the peace of mind safe in the knowledge that their love of pedigreed dogs can be further developed whilst operating within local laws.

### Annual Report (year ending December 2016) continued

I will continue with the strategy of introducing our permit scheme to Local Councils throughout the state but members must remember that there is no quick fix option – it will take time to convince every local council (of which there are 72 in Queensland) to adopt and support a scheme that will protect our members and their hobby.

In closing could I also ask members to keep me informed if they are having difficulties with their Local Council - the sooner you can give me details of the issues you are facing the more likely it is that I can help you to find a solution. Keeping your issues a secret for a year or more (until it reaches the point where Council is threatening to seize dogs being kept on a members' property) and then putting your hand up for assistance puts me and our organisation in an impossible situation – don't be shy – there is nothing that you could tell me that I haven't heard or dealt with in the past.

#### **Principal Activities**

The company was registered as a company limited by guarantee on 10 September 2012, having previously operated as an unincorporated association.

The principal activities of the company during the year were the registration and promotion of pure bred dogs. No significant change in the nature of those activities occurred during the year.

### **Key Performance Measures**

The company measures its own performance through the use of both quantitative and qualitative benchmarks. The benchmarks are used by the Directors to assess the financial sustainability of the company and whether the company's short-term and long-term objectives are being achieved. The Key Performance Measures used are Renewing Full Single Members 3,572 (2015 - 3,483), Full Joint Members 1,210 (2015 - 1,244), New Members 935 (2015 - 833), Litter Registrations 16,290 (2015 - 15,558), Renewing Prefixes 3,171 (2015 - 3,116), New Prefixes 365 (2015 - 350) and Transfers of Dogs 3,662 (2015 - 3,558).

#### **Members Guarantee**

Canine Control Council (Queensland) Limited is a company limited by guarantee. In the event of, and for the purpose of winding up of the company, the amount capable of being called up from each member and any person or association who ceased to be a member in the period prior to the winding up, is limited to \$1. The number of Members at the end of 2016 was 6,723. (2015 – 6,513)

#### **Operating Results**

The consolidated profit of the economic entity for the financial year amounted to \$77,486.

#### **Directors' Benefits**

Your Grounds Committee has had a big year, we have done the catering for 12 Clubs plus our own 3 Shows. When the coffee vendor left us early in the year, we decided to take on the role when we couldn't find another vendor, this was an enormous job for Carolyn and myself. Along with a friend of Carolyn's and a few of our members' daughters, we were able to bank many thousands of dollars of profit to be ploughed back into Durack Grounds.

Jobs completed at and for the benefit of Durack Grounds:

- We installed more invalid parking and smoking areas
- We installed fencing behind the vendors area to stop children running through the area where electric leads were in use
- We installed concrete markers for all camping sites and this was a very large job, over 100 concrete markers
- Following the severe storms in late 2015, we had to repair storm damage to the earthdog fencing
- We repaired the damaged fencing to the off lead area

We had the main building assessed by a Building Certifier following movement of the rear walls of the main building. We had a Certified Plumber come out as per instructions for the Building Certifier to assess the pipes of the building to rule out these as the probable cause of the movement of the rear walls. The Plumber videoed the inside of the pipes and found one pipe fitting with a crack otherwise all was good. In the Building Certifiers report, he identified the cut in the concrete at the front of the building as the probable cause of water getting in under the downstairs flooring and lifting same, thus bowing out the rear walls. I went out and purchased tubes of builders Mastic and sealed the front and rear of the building and it has now dried out under the slab and the walls have moved back nearly into place as per the Building Certifiers findings.

- We placed three whirly birds on the PR container to try and reduce the temperature inside, while this was achieved it wasnt enough for the storage of dry dog food
- We had the grounds treated for ants by Greg Bishop at cost of materials only
- We replaced the rotten garden retaining wall to the left of the main building
- We dug up the old garden in front of the Secretary's office and Helen Acworth replanted this garden

I spent many days in relation to the trespassers in our wetlands with Council meetings, police reports and neighbour consultations. To this end, I finally accomplished his removal on the 16th December. Following his departure and many meetings later, I started the enormous job of cleaning up the mess he left. I spent one full day 12 hours by myself with the aid of a borrowed 12 metre truck and bobcat and one and a half truck loads later, I called it quits. With still more to be picked up, I called for a working bee of members to finish the clean up but this was called off because of heat problems, but because I had already borrowed the truck and bobcat again, I, along with Carolyn and with the assistance of our rear neighbours John and Aliki Koranis, we went ahead to finish the clean up.

During the Christmas/New Year break we installed a permanent smokers area.

- We installed fencing panels between rings 12 and 13 in the parking area to allow room for people to walk through without having to fight through Gazebos
- We also moved the flagpole and installed the plants for the new hedge in front of the main building
- We had the Grounds treated for ant infestation again by Greg Bishop at cost of materials. I might add Greg came up from his work base in NSW to do this free of charge

Following this, I went out and purchased the materials to construct the covers for the container and the rubbish bin at the front gate, I also purchased enough materials to build an extension next to the container to house the Dogs Queensland trailer and car. During the year, we purchased another container for the Lure Coursing people to store their gear in. We have also purchased a new 14 cubic foot freezer and a new 3 door drinks fridge. A shade area for the smokers area is needed and will be erected ASAP along with the completion of the rubbish bin cover at the front gate. There are many more small jobs to be attended to in the not too distant future.

I would at this time like to make special mention to those people who have come along to assist at many of the functions catering or jobs completed on the Grounds, Duncan McAllister, Peter and Sue Hewinson, Carolyn Pearen and Greg Bishop to name but a few.

### **Amenities Zone 2 and 3 Subcommittee**

Zone 2 and Zone 3 enjoyed a successful year of Amenities Shows, raising much needed funds to assist our Clubs in the regional areas.

In Zone 2, one fundraising Show was conducted in conjunction with the Mt Perry Agricultural Society Show as a trial which proved popular and successful; and three Shows were conducted in Bundaberg drawing strong entries.

In Zone 3, three Shows were conducted at Woodstock which were again well supported. Many of the Dogs Queensland Board of Directors and the General Manager also attended these Shows and conducted a forum with members. In addition to this, all visitors assisted with looking after the Judges, stewarding, writing and supporting the Shows in general which was very much appreciated by the exhibitors.

I am pleased to advise that following our successful year the balances of the Zone accounts are healthy with approximately \$1,800 in the Zone 3 account and approximately \$6,000 in the Zone 2 account, a significant increase on the results for the previous year.

It was pleasing that several Clubs in Zone 2 were able to benefit from grants from the Amenities funds during 2016.

I would like to express my thanks to the Sub-Committee members who contributed in a variety of ways and recognise and appreciate those contributions, and for all those who were supportive in any way to the Amenities Shows.

2016 has been a very busy year for Dogs Queensland with both internal and external influences impacting on the organisation.

This has highlighted the fact that the Strategic Plan is not just a document that is printed and left on the shelf to gather dust, but rather a living document that must be reviewed and adapted constantly to account for the topical issues and the environment in which the organisation operates.

I am pleased to report that many of the initiatives listed in the Strategic Plan have been completed and many are in progress. With the legislative changes introduced by the State Government in relation to puppy farming, the organisation's resources have been diverted to this important issue and, as a result, some items in the Strategic Plan have been deferred. A significant amount of the available resources of the organisation have also been engaged in the potential move of the Dogs Queensland Office to Durack, while the Office Review has also been prioritised.

Throughout the process of monitoring the plan and reviewing the plan, there are some items that have been "parked" due to constraints that would prevent them from progressing at the present time.

There has been a lot of work to incorporate the strategic plan into the operation of Dogs Queensland, and this has been done quite successfully at Board level with the Strategic Plan referenced regularly as a consideration in discussions and decisions.

As the current plan is in operation and the focus of the organisation has been primarily to the topical issues we are currently facing, the Committee has adjourned meetings pending the formation of the new Board in March 2017, where it has been recognised that some streamlining, review and refocusing of the Strategic Plan will be required. This will likely be a piece of work coordinated by the Committee or a Working Party.

The need to take a focussed, agreed approach to the outcomes that Dogs Queensland wants to achieve will involve consultation and engagement by our membership and this has been one of the challenges under the existing Strategic Plan.

At the beginning of 2016, the Committee set itself two major tasks that it wished to complete by the end of the year. The first was to complete the revamping of the 2005 Rules in an endeavour to achieve a more user friendly document. The second was to refine the Constitution and to then be able to present this new document, for Member approval and voting, at the 2017 AGM.

The issue of amending and updating the Rules was a fairly long and arduous process. The old Rules documents contained many provisions which were outdated and in need of either replacement or deletion. Added to this, the current Rules also had to be in accordance with all ANKC amendments, which were occurring right up until the end of December 2016. The Committee completed its proposed document towards the end of 2016 and Geoff Lane then added all the necessary ANKC amendments. As a Committee, we feel that the final document is both user friendly and, more importantly, is now sectioned appropriately - with all the Rules correctly located in their relevant sections.

In addition to the Rules, the need for Constitutional amendment was also an area of concern. The Committee felt that a number of the existing provisions needed to be changed, as well as all the references to the transitional period between our old system of governance and our new Democratic system. Suffice to record, the Committee was mindful of the need to complete this exercise within a reasonable timeframe and hopefully be able to present the new document to the 2017 AGM. From September to December, the Committee met regularly and made the changes that they felt appropriate. The Committee expressed its disappointment when a number of the critical changes were knocked back at Board level, but overall the document stayed largely intact. The Committee was also pleased with the positive feedback given from the Solicitors who have also read over the document and made a number of minor suggestions and corrections - all of which were incorporated into the document.

In all, I would like to thank my Committee for the exceptional effort that they have put in over the past 12 months. Personally, this was one of the best Committees I have worked on and everyone should be congratulated for what has been achieved. Lastly, and in particular, I would like to also specially acknowledge Geoff Lane for the hours that he has dedicated to producing these two fine documents. Without Geoff, the task would have been a lot more difficult to achieve.

# Notes to the Financial Statements for the year ended 31 December 2016

## **Note 1: The Company**

The Canine Control Council (Queensland) Ltd (ABN 45 160 285 192) is an incorporated Company Limited by Guarantee.

## Note 2: Statement of significant accounting policies

#### **Basis of preparation**

Canine Control Council (Queensland) Ltd applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 2010-2 Amendments to Australian Accounting Standards arising from Disclosure Requirements.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The Company is a not-for-profit entity for the financial reporting purposes under the Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs modified, where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts provided in the financial statements have been rounded to the nearest dollar.

### **Accounting Policies**

#### (a) Revenue recognition

Revenue is recognised in the year it is earned. Interest revenue is recognised as it accrues. Other revenue includes income from Committees of the Company, affiliated organisations, donations and sponsorship and is recognised on an accrual basis. All revenue is stated at the net of the amount of goods and services tax (GST).

#### (b) Unearned Revenue - Note 12

Includes Membership, Affiliation, Advertising and other fees paid to the Company. These fees are initially recognised as unearned revenue and are progressively recognised as income over the period to which they relate. The unearned portion of these fees at 31 December is included in the account 'unearned revenue'.

#### (c) Income tax

No provision for income tax has been raised as the entity is non assessable for tax under the provisions of the Income Tax Assessment.

#### (d) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition or as part of an item of expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities, which are recoverable from, or payable to, the ATO are classified as operating cash flows.

### (e) Receivables - Note 7

Certain trade debtors' accounts specify a specific due date and those accounts are payable on that date. Other debtors which have no specific due date for payment are normally settled within 30 days. The collectability of debts is assessed at balance date and provision is made for any doubtful accounts.

#### (f) Investments - Note 8

Bank short term deposits (current assets)

The bank term deposits are shown at cost. Interest is accrued at the contracted rate and included in "other debtors".

#### (g) Inventories - Note 9

Inventories are carried at the lower of cost and net realisable value. Items which are considered consumables are expensed in the year of purchase. Inventories are primarily printing material sold to breeders, members and Club organisations.

#### (h) Property, plant and equipment - Note 10

Acquisition

Items of property, plant and equipment are recorded at cost.

Depreciation and amortisation

Items of property, plant and equipment including buildings and ground improvements are depreciated using the diminishing-value method and prime cost method over their estimated useful lives.

The depreciation rates used for each class of asset are as follows:

#### Durack

•	Buildings and ground improvements	2 - 20%
•	Plant and equipment	5 - 50%

### Office

•	Building	2%
•	Plant and equipment	10 - 100%
•	Refurbishments	20%

### (i) Payables - Note 11

Liabilities are recognised for amounts to be paid in the future for goods or services received, whether or not billed to the Company. Trade accounts payable are normally settled within 30 days.

#### (j) Employee Entitlements - Note 13

The provisions for Short Term Employee Benefits to wages, salaries and annual leave represent the amount which the Company has a present obligation to pay resulting from employees' services provided up to the balance date. The provisions have been calculated at amounts based on current wage and salary rates.

#### (k) Other Long Term Employee Benefit - Note 13

Provision with respect to long service leave is made on the basis of the total nominal entitlement of permanent employees from 5 years after commencement of employment. The provision has been calculated at amounts based on current wage and salary rates.

The Board is satisfied that this estimate reliably represents the present value of future cash flows to be made by the Company in respect to services provided by employees up to the reporting date.

The Company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the Company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

#### (I) Superannuation plans

The Company contributes to several specific superannuation plans. Contributions are charged to the income statement as incurred.

### (m) Financial Instruments - Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Company commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted)

#### Classification and subsequent measurement

Financial instruments are subsequently measured at fair value, amortised cost using the effective interest method, or cost. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as the amount at which the financial asset or financial liability is measured at initial recognition less principal repayments and any reduction for impairment, and adjusted for any cumulative amortisation of the difference between that initial amount and the maturity amount calculated using the effective interest method.

## Note 2: Statement of significant accounting policies (continued)

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying amount with a consequential recognition of an income or expense item in profit or loss.

#### (i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

#### (ii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the Company's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

### **Impairment**

At the end of each reporting period, the Company assesses whether there is objective evidence that a financial asset has been impaired. A financial asset or a group of financial assets will be deemed to be impaired if, and only if, there is objective evidence of impairment as a result of the occurrence of one or more events (a "loss event"), which has an impact on the estimated future cash flows of the financial asset(s).

In the case of financial assets carried at amortised cost, loss events may include: indications that the debtors, or a group of debtors, are experiencing significant financial difficulty, default or delinquency in interest or principal payments; indications that they will enter into bankruptcy or other financial reorganisation; and changes in arrears or economic conditions that correlate with defaults.

#### Recoverable amount

The carrying amounts of non-current assets valued on the cost basis are reviewed to determine whether they are in excess of their recoverable amount at balance date. If the carrying amount of a non-current asset exceeds the recoverable amount, the asset is written down to the lower amount.

The write down is expensed in the reporting period in which it occurs. In assessing recoverable amounts, the relevant cash flows have been discounted to their present value.

For financial assets carried at amortised cost (including loans and receivables), a separate allowance account is used to reduce the carrying amount of financial assets impaired by credit losses.

After having undertaken all possible measures of recovery, if the management establishes that the carrying amount cannot be recovered by any means, at that point the written-off amounts are charged to the allowance account or the carrying amount of impaired financial assets is reduced directly if no impairment amount was previously recognised in the allowance accounts.

When the terms of financial assets that would otherwise have been past due or impaired have been renegotiated, the Company recognises the impairment for such financial assets by taking into account the original terms as if the terms have not been discounted to their present value.

### Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expire or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset.

Financial liabilities are derecognised where the related obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

#### (n) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes for the current financial year.

## (o) Critical Accounting Estimates and Judgements

The Directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.
