Chairperson's Report

On behalf of the Board of Directors, I submit the following report for members' consideration upon the activities of Canine Control Council (QLD) Ltd trading as Dogs Queensland, during the year ended 31 December 2017.

Financial Results

The audited financial statements for the last calendar year, along with the unqualified certification of the accounts by the independent auditor, show a loss of \$62,912. This figure is down by \$140,397 from the prior year, and overall is not in line with our budget expectations, and highlights the need for stronger strategic efforts and financial controls. Litter Registration income increased by \$36,490 whilst income from other key areas such as administration fees from shows, prefixes and printing decreased by \$53,044. The bulk of the reduction in prefix income was a flow on effect from the board's decision to introduce a 12 month waiting period for any new member to apply for a prefix. Professional and Legal costs increased by \$8,916 which also takes into account the recruitment costs for our new CEO. Magazine expenditure decreased by \$12,440, however our marketing costs increased by \$31,570 mainly due to the purchase of new stock items to be used for resale at events. The bottom line profit also suffered as a result of costs in relation to the relocation of the office, which includes \$13,090 for storage and removalist expenses.

The Board of Directors determined midway through 2017 that the services of a professional CEO should be engaged to examine strategies to turn around the financial position of the organisation, to review alternative income streams, reduce our overall overheads, to ensure the sustainability and foster the desired growth for Dogs Queensland.

Thanks must go to our retired Grounds Manager Mr Bob Dorr, former assistant Mr Michael Watt, to Mr Rodney Vernon and Mr Kevin Zimmerle for all their hours of volunteer work, and our newly appointed grounds manager Mr Kevin McKay. Our Grounds continue to be the envy of every other ANKC Member Body and are always presented in immaculate condition.

The Board of Directors rely heavily on the activities of a number of Committees and Working Parties to carry out delegated responsibilities to ease the workload which would otherwise consume the monthly Board Agenda. To the Chair's and members of all our Committees and Working Parties, I extend a sincere vote of thanks of both the Board and the membership.

Relocation of the Dogs Queensland Office of Durack

During the year, the Dogs Queensland office was relocated from Fortitude Valley to Durack. After an extensive refit to the downstairs area of our Durack complex, the tedious task of relocating the office took place in August 2017. There has been much positive feedback from the members in relation not only to the move to Durack, but also the presentation and setup of the new office area. I would like to thank Duncan McAllister and Shane Avery for their personal contributions during the relocation process. All of these volunteers contributed many hours to ensure a smooth transition from Fortitude Valley to Durack.

Events

Dogs Queensland held a number of events in 2017 which were used in the promotion of our hobby and our organisation. Our major event was the All Dogs Sports Spectacular (ADSS), which generated a huge public interest and was up on overall attendance from the previous years. It is a wonderful sight to walk around and see all the different types of activities our hobby is about from Conformation showing, to Agility, to Dances with Dogs. This overall view of the hobby was extremely well received by the public, and the word of mouth we have received is worth its weight in gold. Once again we were able to work closely with Ronald McDonald House and Delta Therapy Dogs, and we hope to continue this important partnership in the years to come. Thanks must go to the small, but incredibly dedicated Committee that run the ADSS, which includes Norma Zimmerle, Sharon Munro, Lawrie Knauth, Lynn Neilson, David Weil, Carolyn Pearen, Joy Lanham and Helen Mackie.

In August each year we are part of the Brisbane Royal Show (EKKA) with our Dogs Queensland Promotion Stand. My sincere thanks must go to Helen Mackie and the dedicated workers who ran this stand day after day. This year's stand was again beyond expectation, with our show bags selling at a rapid rate.

The third ever 'Directors' Show' for Dogs Queensland was also conducted this year. This show is designed to allow the Directors to give something back to the membership. Each Director donated towards the trophies for the event, and also donated their time by working at the show. All profits from the event go back into the Durack Committee for further development of various projects across our diverse State. Planning has already begun for the 2018 Directors' Show, and the Board hope it will be bigger and better than in previous years.

The National Junior Handler Final was held in Queensland this year, as part of our annual Dog and Puppy of the year competition. The event was a complete success, and I can proudly boast that our own Brooke Reading was the runner up in the national final. A huge vote of thanks must go to the Junior Handlers Committee for their efforts in coordinating and organising this event. Particular thanks must go to Miss Ainslie Carius for the countless hours that she contributed to making this event the success it was.

Appointment of a Chief Executive Officer

As I have previously pointed out, the Board agreed to engage the services of an experienced Chief Executive Officer (CEO), to help drive our organisation further ahead, provide more strategic focus and enhance our reputation and profile as the peak dog body in Queensland.

In late November 2017 the Board successfully employed the services of Mr Brian Menke, who will commence work for Dogs Queensland on the 8th of January 2018 as our CEO.

Brian is an accomplished CEO, with significant expertise and experience in both the small and "big box" retail sector. His experience has seen him deliver at both strategic and operational levels across the broad spectrum of operations, including coaching and developing, managing change, sales and revenue streams, profit protection, online marketing and development of new business.

He has proven results in developing strategy and operational planning to respond to business requirements and customer/member expectations, leading significant change in complex environments and achievement of stretch targets in competitive markets. He is passionate about the importance of managing relationships and partnering, based on a solution focused, team based ethos.

Brian will be tasked with executing strategies across human resources, marketing, fundraising and program delivery areas. He will oversee community and public relations and be tasked to enhance the Dogs Queensland name throughout the wider community. This engagement is a new approach for Dogs Queensland, and we firmly believe that with Brian's appointment, our organisation will see some positive changes over the next twelve months and into the future. We ask that members be patient during Brian's first few weeks while he gets his bearings and assesses the priorities of his role into the future.

We are now into our fifth year of our association with our major sponsor, Royal Canin. Their product sponsorship for our events is exceptional, and very much appreciated. On behalf of the Board, the membership and the exhibitors, I thank Royal Canin most sincerely for their continued support of Dogs Queensland.

2018 is poised to be one of the biggest years ever for Dogs Queensland, with many changes for the better on the horizon. We will undertake many new initiatives to better establish our organisation, our brand and who we are.

Government and Agency Liaison Officer Report

Annual Report (year ending December 2017)

The year that was 2017 began with a bang as members rallied to prepare and send their written submissions to Somerset Regional Council. For the past 5 years Somerset Regional Council had posed an enormous challenge – there is no doubt that the majority of Somerset Regional Council Councillors were not supportive of a relaxation of their local laws which applied to the keeping and breeding of dogs.

However, a combination of a full electronic presentation to the Mayor and his fellow Councillors backed up by an enthusiastic group of dedicated members resulted in the first step towards a full breeder permit scheme being adopted by this very difficult local Council. In March of 2018 there will be a follow up presentation which will determine whether members have done enough to allow Somerset Regional Council to adopt the full 9 dog breeder permit scheme. Compliance with existing local laws will be the primary measure and I expect that our members will have complied with the current local laws sufficiently to give Somerset Regional Council the confidence to further modify their local laws in favour of our resident members.

Some headway was also achieved with Ipswich City Council – yet another very tough Council to deal with.

Ipswich City Council was in the news for all the wrong reasons during 2017 – dumping of interstate waste, a popular Mayor facing very serious corruption charges and a mayoral election that delivered a result that was not the best outcome for our Dogs Queensland members. As this report goes to members Ipswich City Council are conducting a full review of their fees and charges – in particular the annual dog registration fees which are the highest in Queensland. Ipswich City Council does make available discount and registration fees where individual dogs have been assessed against an obedience examination. Advice from Dogs Queensland Directors Mrs B Murfet and Mr L Knauth (both highly qualified Obedience Judges) was that the obedience test was far too stringent – the test required that dogs pass a test that would prove difficult even for CD qualified dogs.

Ipswich City Council have taken those concerns on board – they are also using a comprehensive table of dog related fees and charges that draws information from all 72 Councils across Queensland. I am confident that we may well see Ipswich City Council commit to extending a 50% discount for resident Dogs Queensland members to take effect before registration renewals fall due on 30th June 2018. Once we are confident that our members are taking up the benefit of discounted registration fees we will once again submit a formal proposal for changes to the local laws that affect the keeping and breeding of dogs. I believe that enlisting the help of our resident members to lobby their local Councillor could deliver us the outcomes we are seeking. Again, it may well be the level of compliance with existing local laws that will get our breeder permit scheme over the line.

Members who breed from their pedigreed dogs hardly need to be reminded that the State Dog Breeders Registry came into effect in May 2017.

I do expect that Biosecurity Qld may wish to conduct a review of the registry on or about the first anniversary of the registry going live. There are already some issues noted down for discussion – in particular charging an annual renewal fee for all breeders who appear on the database.

Strong working relationships continue with Logan City Council and Moreton Bay Regional Council. Both Councils are now on a quarterly rolling meeting schedule to cover off any issues that may be causing those Councils (or our members) any concerns. There have been some administrative challenges that have caused some of our members some headaches particularly in the area of annual renewals of fees and charges. Corrective measures are in place that should see those bugs ironed out of the administrative systems by mid-year.

In closing I should make special mention of the member support received at two regional member information evening held recently. Members who reside in Somerset and Lockyer Valley regions attended these information evenings in force – I believe that demonstrates the level of importance that members place on the development of closer working relationships with Local Councils. During 2018 there is a plan to roll these meetings out to other regions – attending those meetings will give members an opportunity to discuss any difficulties they may be experiencing with their Local Council. More importantly it will give us an opportunity to agree a strategy and how best to implement measures that will in the longer term mean better and more relaxed local law provisions for our members and their dogs.

With the approval of the Dogs Queensland Board of Directors I will continue with the strategy of introducing our breeder permit scheme to Local Councils throughout the State. However, members must remember that there is no quick fix option – it will take time to convince every local council (of which there are 72 in Queensland) to adopt and support a scheme that will protect our members and their chosen hobby.

In closing could I also ask members once again to keep me informed if they are having difficulties with their Local Council – the sooner you can give me details of the issues you are facing the more likely it is that I can help you to find a solution. Keeping your issues a secret for a year or more (until it reaches the point where Council is threatening to seize dogs being kept on a members' property) and then putting your hand up for assistance puts me and our organisation in an impossible situation – don't be shy – there is nothing that you could tell me that I haven't heard or dealt with in the past.

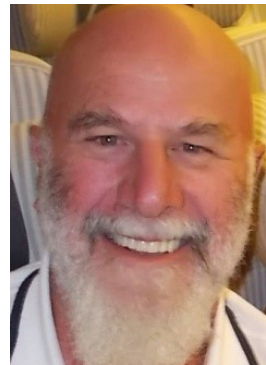

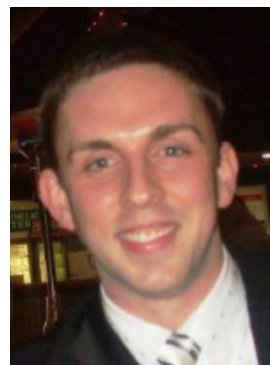

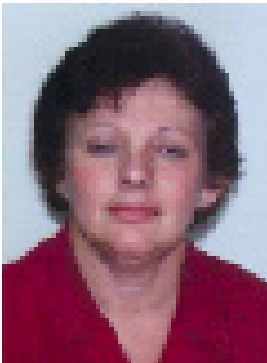

Principal Activities

The company was registered as a company limited by guarantee on 10 September 2012, having previously operated as an unincorporated association.

The principal activities of the company during the year were the registration and promotion of purebred dogs. No significant change in the nature of those activities occurred during the year.

Key Performance Measures

The company measures its own performance through the use of both quantitative and qualitative benchmarks. The benchmarks are used by the Directors to assess the financial sustainability of the company and whether the company's short-term and long-term objectives are being achieved. The Key Performance Measures used are Renewing Full Single Members 3,765 (2016 – 3,572), Full Joint Members 1,247 (2016 - 1,210), New Members 1,083 (2016 - 935), Litter Registrations 16,418 (2016 - 16,290), Renewing Prefixes 2,969 (2016 - 3,171), New Prefixes 163 (2016 - 433) and Transfers of Dogs 3,500 (2016 - 3,662).

Members Guarantee

Canine Control Council (Queensland) Limited is a company limited by guarantee. In the event of, and for the purpose of winding up of the company, the amount capable of being called up from each member and any person or association who ceased to be a member in the period prior to the winding up, is limited to \$1. The number of Members at the end of 2016 was 6,887. (2016 – 6,723)

Operating Results

The consolidated loss of the economic entity for the financial year amounted to \$62,912.

Subsequent Events

No matter or circumstance has arisen since the end of the financial year, which has significantly affected or may significantly affect:

- (a) the Company's operations,
- (b) the result of those operations,
- (c) the Company's state of affairs.

Dividends

The company is prohibited under its constitution from payment of dividends to its members.

Indemnification of Company Officers and Auditors

During the financial year, the company paid a premium in respect of a contract insuring the Directors of the company (as named above), the company secretary and all executive officers of the company and of any related body corporate against liability incurred as such a director, company secretary or executive officer to the extent permitted by the Corporations Law.

The company has not otherwise, during or since the end of the financial year, indemnified or agreed to indemnify an officer or auditor of the company or of any related body corporate against a liability incurred as such an officer or auditor.

Directors' Benefits

Within the financial year, no Director of the company has received or become entitled to receive any benefit by reason of a contract made by the company or a related corporation with the Director or with a firm of which he is a member or with a company in which he has a substantial financial interest.

Objectives:

The objectives of the Company shall be:

1. to be the governing canine body for the State;
2. to maintain membership of the National Canine Body and to enhance and promote its standing within that body;
3. to promote and encourage the development and responsible breeding of healthy purebred registered dogs throughout the State;
4. to promote and encourage the recreation, sport, exhibition and training of the CCCQ Ltd registered dogs throughout the State
5. to promote and encourage the training of all dogs throughout the State;
6. to promote the development and improvement of the health and welfare of purebred registered dogs throughout the State;
7. to promote and encourage membership of the CCCQ Ltd with its attendant advantages and privileges;
8. to promote and develop policies and regulations that shall be used as a quality benchmark for dog breed standards ensuring that the welfare and health of dogs remains paramount;
9. to promote, develop and maintain close working relationships with all levels of Government (Commonwealth, State and Local) to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
10. to promote, develop and maintain close working relationships with other organisational bodies and other stakeholder groups with similar objectives to ensure the best interests of members and the registered dogs of the CCCQ Ltd are protected and enhanced;
11. to promote and encourage public interest and participation in the CCCQ Ltd sanctioned exhibitions and events;
12. to promote and encourage scientific research into canine related health issues both in Queensland and interstate;
13. to act as the control of the CCCQ Ltd registered dog related activities throughout Queensland including:
 - (i) to administer Rules for the conduct and regulation of all the CCCQ Ltd exhibitions and events;
 - (ii) to keep a register of purebred dogs and their ownership;
 - (iii) to keep a register of all breeder prefixes;
 - (iv) to administer regulations relating to purebred dogs;
 - (v) to grant or withhold affiliation to bodies with similar objectives referred to as affiliated bodies;
 - (vi) to administer certificates, awards, championships and titles;
 - (vii) to assist in the prevention of illegal or dishonest practices in relation to dog related activities in Queensland; and
 - (viii) to facilitate the operation of independent registers for Non-Conformation activities including registers for non-purebred dogs;
14. to promote and encourage development of knowledge and skills relating to canine activities.

To achieve these objectives, the entity has adopted the following strategies:

- Attract and retain qualified staff to administer the business of the entity and provide member services which meet consistent standards of best practice as compared to similar entities and this is evidenced by low staff turnover
- Attract and retain volunteers from within the membership who are committed to the entity's objectives
- Both staff and volunteers will continue to work towards both the entity's short and long term objectives
- Continue to keep open the lines of communication with all Government bodies on all aspects of purebred dogs
- Collect, verify and publish information relating to purebred dogs and the breeding and exhibition of purebred dogs
- Keep and maintain a canine register of purebred dogs
- Promote the holding of exhibitions and to conduct exhibitions
- Charge fees for all aspects of the business that the company conducts

The Conformation Judges Committee would like to congratulate the new "All Breeds" Judges - Ros Seare, Pam Brown and Chris McGreevy.

Trainees achieved a high percentage pass rate in both the Theory and Practical examinations in 2016/2017.

Open Show entries continue to be an issue. We had hoped that "Champion Sweepstakes" at Open Shows may have encouraged exhibitors to enter their champion dogs which would have given trainee Judges quality dogs to examine.

However, this has achieved only limited success. We also encourage Clubs to conduct "Match Days" to assist trainee Judges to gain valuable 'Hands-on' experience.

Your Grounds Committee has had a very big year at Durack. It commenced during the 2016 Christmas, New Year break when we removed the whirly birds on the P.R container and constructed a roof above it. To reduce the heat in the container. We then fabricated funnels and replaced the whirly birds. Then we constructed a drive- through garage for the P.R. Caravan and D.Q vehicle.

Our next project was to re- construct the drainage system in front of the old club house BBQ area and old toilet block. We also placed 4 panels of pool fencing at the end of the drainage pipe to (a) protect the pipe and (b) to stop idiots driving into the drain. We also place a further 2 panels between the two group 5 rings to allow exhibitors access to the rings.

A trench was then dug to supply power to the Lure Coursing grounds, we were unable to get the trench deep enough for normal power cables (because of the underground rubbish fill in the area), we had to concrete the power into the ground.

We then constructed the rubbish bin cover at the front gate (as per BCC requirement). The next project was to replace the urinal and 2 more toilets installed in the bottom toilet block.

All the floors were epoxy painted, and new wall and floor copping in both toilet blocks, and to the loading bay for the main building, and the toilets for the kitchen of the main building. We constructed the ambulance stand and painted it.

We place an apron of concrete in front of the Agility- Obedience shed at the northern side of Durack.

A complete trailer was built to store all our ring gear for show days as well as the exam tables, writer's tables, chair ropes and hand basins. We constructed shelving to store all the gear needed to operate Durack (e.g. Toilet paper and hand towels etc).

We dug a trench to lay the power wire to connect the rear shed with lighting.

Conduit and wiring was laid in the Obedience shed and replaced the fill. We installed a concrete slab for the lure coursing people for them to construct a BBQ for lure coursing days.

During this Christmas break we also excavated the area for the War and Service Dog Memorial, and we concreted the necessary paths and garden areas in preparation. It has been a very busy time over the holiday period for your Grounds Committee.

The Dogs Queensland Canine Health and Welfare Committee (CHWC) promotes the health and welfare of pedigree dogs through education, encouragement of research, breed improvement schemes and responsible breeding practices to ensure that dogs owned and bred by members live healthy, happy lives with caring and informed owners. The role of this Committee is to provide advice to the Directors of Dogs Queensland on health and welfare issues. I would like to thank the members of the Committee for their time, commitment and ideas that they bring.

Throughout the past year the CHWC has been working hard behind the scenes with the proposal to the Board of Directors of the new Dogs Queensland DNA Program (Parentage). The CHWC also assisted with the implementation of this DNA Program for Parentage confirmation in Queensland. This is the first in Australia. The program commenced on January 1, 2018 on a trial basis for the first 12 months. This DNA Program (Parentage) is mandatory for all members and all puppies produced from matings on or after 1 January must have their DNA Parentage confirmed prior to registration. This is a step forward for the purebred dog and confirmation of pedigrees.

Health Seminars are a priority and CHWC have had several very successful seminars over the past year covering varied topics from Neosporosis to Animal Behavior, with more to come in 2018.

The implementation of the Animal Management (Protection Puppies) Act, has had the Committee looking at ways we can assist our breeders to conform to this new legislation and continue with their hobby of breeding and showing purebred dogs. With this in mind, the Breeder Prefix Exam is being looked into and is on the Agenda for implementation in the near future. The assistance from Dr Gaille Perry with last year's proposal is appreciated and this will be included in the final product to be put forward to the Board of Directors later in 2018.

Field Officers (FO) are another initiative from the desk of the CHWC. This is the next major proposal the CHWC will be putting forward to the Board of Directors for perusal and approval. This will also work in with the recent Legislation and proposed Breeder Accreditation Scheme to be introduced. We are hopeful these initiatives will assist our members in their dealings with authorities. Over the next 12 months, the CHWC has many ideas and projects on the agenda. Health testing Clinics are in the works, with Specialist Vets lined up and ready to roll out in 2018 (dates to be confirmed). Research is also on the agenda and CHWC plans to support valid research programs. We are hoping to take these programs throughout Queensland making them available to all members across the State.

This is a very progressive, confident and pro-active Committee and we look forward to the next 12 months.

Notes to the Financial Statements for the year ended 31 December 2017

Note 1: The Company

The Canine Control Council (Queensland) Ltd (ABN 45 160 285 192) is an incorporated Company Limited by Guarantee.

Note 2: Statement of significant accounting policies

Basis of preparation

Canine Control Council (Queensland) Ltd applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 2010-2 Amendments to Australian Accounting Standards arising from Disclosure Requirements.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The Company is a not-for-profit entity for the financial reporting purposes under the Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs modified, where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts provided in the financial statements have been rounded to the nearest dollar.

Accounting Policies

(a) Revenue recognition

Revenue is recognised in the year it is earned.

Interest revenue is recognised as it accrues.

Other revenue includes income from Committees of the Company, affiliated organisations, donations and sponsorship and is recognised on an accrual basis. All revenue is stated at the net of the amount of goods and services tax (GST).

(b) Unearned Revenue – Note 12

Includes Membership, Affiliation, Advertising and other fees paid to the Company. These fees are initially recognised as unearned revenue and are progressively recognised as income over the period to which they relate. The unearned portion of these fees at 31 December is included in the account 'unearned revenue'.

(c) Income tax

No provision for income tax has been raised as the entity is non assessable for tax under the provisions of the Income Tax Assessment.

(d) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition or as part of an item of expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities, which are recoverable from, or payable to, the ATO are classified as operating cash flows.

(e) Receivables - Note 7

Certain trade debtors' accounts specify a specific due date and those accounts are payable on that date. Other debtors which have no specific due date for payment are normally settled within 30 days. The collectability of debts is assessed at balance date and provision is made for any doubtful accounts.

(f) Investments - Note 8

Bank short term deposits (current assets)

The bank term deposits are shown at cost. Interest is accrued at the contracted rate and included in "other debtors".

Note 2: Statement of significant accounting policies (continued)

(f) Investments - Note 8

Bank short term deposits (current assets)

The bank term deposits are shown at cost. Interest is accrued at the contracted rate and included in "other debtors".

(g) Inventories - Note 9

Inventories are carried at the lower of cost and net realisable value. Items which are considered consumables are expensed in the year of purchase. Inventories are primarily printing material sold to breeders, members and Club organisations.

(h) Property, plant and equipment - Note 10

Acquisition

Items of property, plant and equipment are recorded at cost.

Depreciation and amortisation

Items of property, plant and equipment including buildings and ground improvements are depreciated using the diminishing-value method and prime cost method over their estimated useful lives.

The depreciation rates used for each class of asset are as follows:

Durack

- Buildings and ground improvements 2 - 20%
- Plant and equipment 5 - 50%

Office

- Building 2%
- Plant and equipment 10 - 100%
- Refurbishments 20%

(i) Payables - Note 11

Liabilities are recognised for amounts to be paid in the future for goods or services received, whether or not billed to the Company. Trade accounts payable are normally settled within 30 days.

(j) Employee Entitlements - Note 13

The provisions for Short Term Employee Benefits to wages, salaries and annual leave represent the amount which the Company has a present obligation to pay resulting from employees' services provided up to the balance date.

The provisions have been calculated at amounts based on current wage and salary rates.

(k) Other Long Term Employee Benefit - Note 13

Provision with respect to long service leave is made on the basis of the total nominal entitlement of permanent employees from 5 years after commencement of employment. The provision has been calculated at amounts based on current wage and salary rates.

The Board is satisfied that this estimate reliably represents the present value of future cash flows to be made by the Company in respect to services provided by employees up to the reporting date.

The Company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the Company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

(l) Superannuation plans

The Company contributes to several specific superannuation plans. Contributions are charged to the income statement as incurred.

(m) Financial Instruments - Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Company commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted)

Classification and subsequent measurement

Financial instruments are subsequently measured at fair value, amortised cost using the effective interest method, or cost. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as the amount at which the financial asset or financial liability is measured at initial recognition less principal repayments and any reduction for impairment and adjusted for any cumulative amortisation of the difference between that initial amount and the maturity amount calculated using the *effective interest method*.

Note 2: Statement of significant accounting policies (continued)

The *effective interest method* is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying amount with a consequential recognition of an income or expense item in profit or loss.

(i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

(ii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the Company's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amortisation process and when the financial asset is derecognised.

Impairment

At the end of each reporting period, the Company assesses whether there is objective evidence that a financial asset has been impaired. A financial asset or a group of financial assets will be deemed to be impaired if, and only if, there is objective evidence of impairment as a result of the occurrence of one or more events (a "loss event"), which has an impact on the estimated future cash flows of the financial asset(s).

In the case of financial assets carried at amortised cost, loss events may include: indications that the debtors, or a group of debtors, are experiencing significant financial difficulty, default or delinquency in interest or principal payments; indications that they will enter into bankruptcy or other financial reorganisation; and changes in arrears or economic conditions that correlate with defaults.

Recoverable amount

The carrying amounts of non-current assets valued on the cost basis are reviewed to determine whether they are in excess of their recoverable amount at balance date. If the carrying amount of a non-current asset exceeds the recoverable amount, the asset is written down to the lower amount.

The write down is expensed in the reporting period in which it occurs. In assessing recoverable amounts, the relevant cash flows have been discounted to their present value.

For financial assets carried at amortised cost (including loans and receivables), a separate allowance account is used to reduce the carrying amount of financial assets impaired by credit losses.

After having undertaken all possible measures of recovery, if the management establishes that the carrying amount cannot be recovered by any means, at that point the written-off amounts are charged to the allowance account or the carrying amount of impaired financial assets is reduced directly if no impairment amount was previously recognised in the allowance accounts.

When the terms of financial assets that would otherwise have been past due or impaired have been renegotiated, the Company recognises the impairment for such financial assets by taking into account the original terms as if the terms have not been discounted to their present value.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expire or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset.

Financial liabilities are derecognised where the related obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

(n) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes for the current financial year.

(o) Critical Accounting Estimates and Judgements

The Directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.

(p) New Accounting Standards for Application in Future Periods

The AASB has issued new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods. The company has decided against early adoption of these Standards. The following table summarises those future requirements, and their impact on the Company.




