REQUIREMENTS FOR SINGLE BREED LICENCE - GERMAN SHEPHERD DOG

- 1. Make application to Dogs Queensland for a single breed licence you must meet all Dogs Qld requirements for a single breed licence prior to applying.
- 2. Be 18 years of age or older
- 3. Have been a member of an ANKC member body for a minimum of eight (8) years during the ten (10) years immediately prior to the date of application.
- 4. Have bred at least five (5) litters under own prefix
- 5. Have had at least five (5) animals under their own prefix that have received the excellent grading in the conformation ring.
- 6. Have acted as a steward on at least four (4) occasions at an all breeds group event.
- 7. The applicant will provide a supporting statement from their club of domicile. This should include details of their involvement in their GSDCA member club. The information that must be detailed and confirmed by the club will be, but is not limited to:

Current financial member of a member club of the GSDCA
Years of membership of club and member body
History of involvement both current and past in the club. ie all positions held including length of time served in that position
The supporting statement shall accompany the application form

8. Complete and submit the approved enrolment form which must include evidence of the above criteria and be accompanied by the prescribed fee. A copy of this enrolment form and supporting evidence should be forwarded to the GSDCA by the applicant.
