#### **NOTICE TO SHOW SECRETARY:**

SCHEDULES (two (2) copies) must be submitted to the General Manager, Dogs Queensland five (5) months prior to the date of the Show, complete with <u>ALL</u> Judges' contracts and payment for advertising. (Refer Dogs Queensland Rules 42.1, 42.3 and 42.4).

The Schedule is to be completed in triplicate (the third copy to be retained by the Club).

If appointing an overseas Judge, it is the responsibility of the Club to obtain a clearance from the relevant overseas Control and have the Judge compete an ANKC Judge's form (when contracting a Judge from overseas (New Zealand being the exception), you must apply to Dogs Queensland, who will apply for a clearance from the ANKC on your Club's behalf).

When contracting Judges for your Show, please remember to include ALL class(es), breed(s) and special classes that they will be judging. It is the Club's responsibility to ensure that Rules 69.1 to 69.6 are not infringed.

Closing date of entries must be at least twenty-one (21) clear days prior to the date of the Show.

Clubs are reminded that they must cater for Trophies / Sashes for the following: Breed and General Specials winners. **Note:** Minimum value of trophies – twenty percent (20%) of entry fees (excluding cost of sashes); the value of trophies should be appropriate having regard to entries.

R1O, MARKED CATALOGUE, SHOW MANAGER'S REPORT, SHOW RESULTS AND ANY OTHER RELATED PAPERWORK MUST BE FORWARDED TO THE DOGS QUEENSLAND OFFICE WITHIN FOURTEEN (14) DAYS OF THE SHOW, TOGETHER WITH THE SURCHARGE PAYMENT. ANY INCIDENT REPORTS SHOULD BE DEALT WITH BY THE CLUB ON THE DAY AND FORWARDED BY THE SHOW MANAGER TO THE DOGS QUEENSLAND OFFICE WITHIN TWO (2) DAYS OF THE SHOW.
