Logbook

This logbook is designed to help trainees keep records of their learning. It is not necessary to use this format and alternative formats, electronic or hard copy are acceptable. Use whatever best serves your learning style.

The logbook needs to be shareable with the Dogs Queensland Tracking and Track and Search Subcommittee in accordance with the Judges Training and Assessment Scheme (JTAS) requirements.

It should cover all aspects mentioned in the JTAS. In particular, you need to keep records of each of at least the 12 tracks you are required to have stewarded and the 3 tracks you shadow judged for each level, including the maps, notes about how the track worked in practice, and whether and how you would make any necessary changes.

Learning objectives for tracking judge trainees

The following objectives are intended to guide the trainee's learning. Assignments and mock exams will be provided by the Tracking and Track and Search Subcommittee to help the trainee.

To be ready to apply for elevation the trainee should be able to:

- 1 For trainees who do not hold a current judge's license, recall the relevant rules and regulations of Dogs Queensland relating to judges' conduct and obligations.
- 2 Recall the Dogs Queensland rules and regulations for Tracking Trials.
- 3 Explain the roles and responsibilities of a Tracking Judge in promoting the sport.
- 4 Explain how dogs are able to scent and track and how scent may behave under different conditions.
- 5 Perform the role of Trial Manager for a Dogs Queensland Affiliated Club, including contracting judges, submitting a schedule to Dogs Queensland, preparing a run sheet for the trial, preparing and submitting the Trial Manager's report and other required documents to Dogs Queensland at the end of the trial.
- 6 Design, map and set out tracks for each of the following levels: TD, TDX, Tracking Champion and Tracking Grand Champion.
- 7 Steward tracks at all levels assisting the judge as required; organise competitors, track layers and cross-track layers so that a test runs smoothly; and noting how dogs manage the conditions of each track.
- 8 Shadow judging (often while stewarding), discussing the dog's performance and grade with the judge, and making the presentation.

Training Requirements

You may apply to be assessed for elevation to become a licensed Judge when you have met the following training requirements.

1. Conducted at least two group sessions of practical training helping other people in tracking.
2. Stewarded 12 tracks, ideally in at least two locations, working with at least two different judges. These should include tracks at TD, TDX, Tracking Champion and Tracking Grand Champion levels. Stewarding must include mapping the tracks and organizing the track layers and competitors.
3. Manage a Tracking Trial for a Dogs Queensland Affiliated Club, including contracting judges, submitting a schedule to Dogs Queensland, preparing a run sheet for the trial, preparing and submitting the Trial Manager's report and other required documents to Dogs Queensland at the end of the trial.
4. Shadow judge 3 dogs for TDX title tests, under the supervision of the judge. This will include designing, mapping, organising and stewarding the tracks and making the presentation at the end.
5. Shadow judge 3 dogs for Tracking Champion and Tracking Grand Champion tests under the supervision of the judge. This will include designing, mapping, organising and stewarding the tracks and making the presentation at the end.
6. Successfully completed assignments/mock examinations prepared by the Tracking and Track and Search Subcommittee covering Dogs Queensland and ANKC Inc rules and regulations, tracking scenarios, ethics of tracking and judging, and other relevant topics.

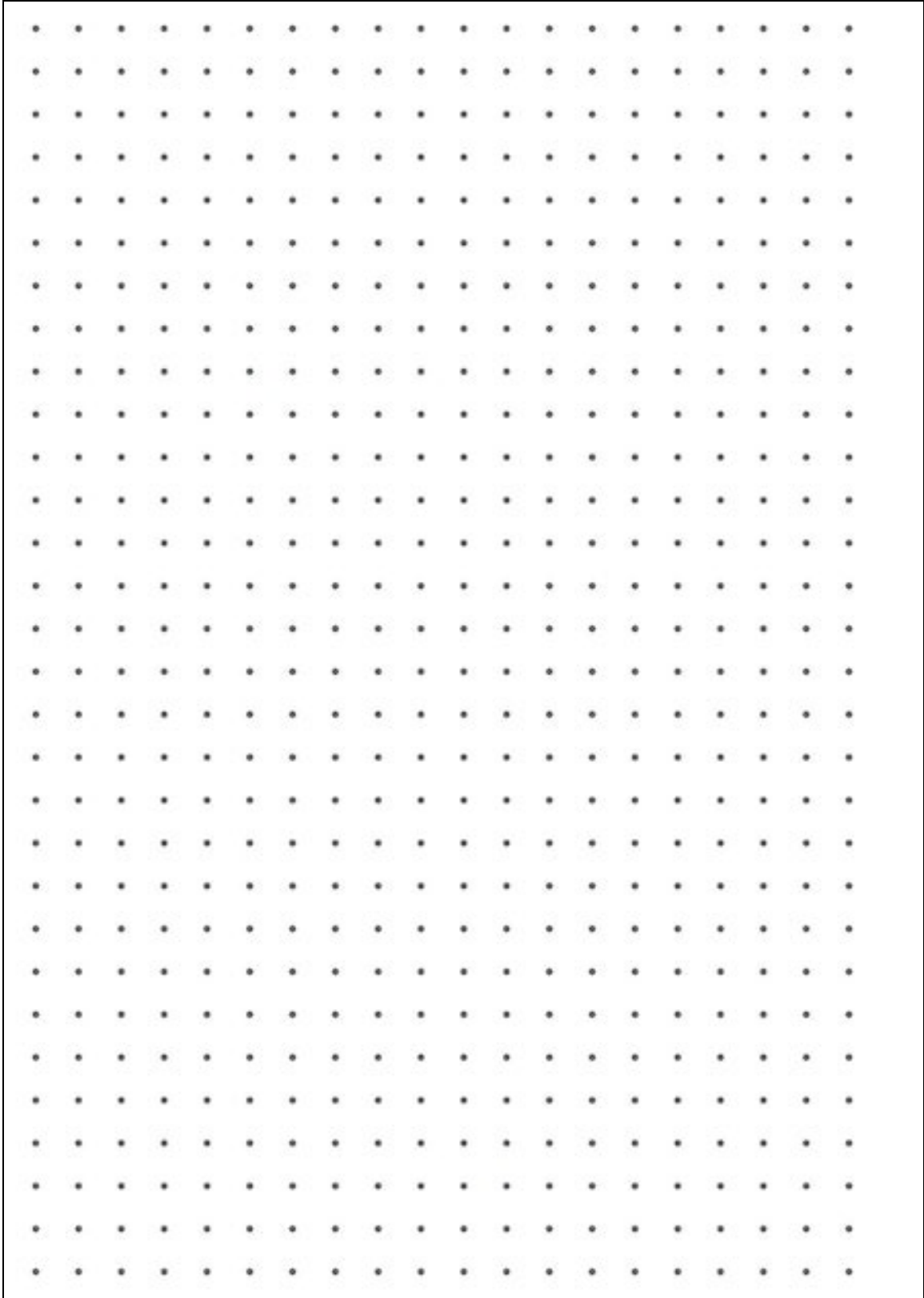
