Directors noted the reports provided with the General Manager suggesting the CWLO attend the Board meeting once a quarter. Discussion followed on the ANKC record update program, including income being received for transfer fees vs assisting breeders to update records, whether seller and/or buyer signatures were required on transfer forms and the issue of reminders. It was noted an amnesty had been provided to enable breeders to update records and the feedback on the program had been largely positive.

- Increasing communication and engagement with members and ensuring there was equal access to Dogs Queensland services across the three zones.
- Zoom forums with Zones 2 and 3 had been well received, were cost effective and members were able to ask
  questions and raise issues. Face to face meetings were also required given the demographic of many Dogs
  Queensland members.

- Support for the proposal, however it needed to be sustainable and balanced. Informal forums or meetings could
  be organised as part of a weekend event, with Directors available for members to approach and discuss issues.
   The forums would need to be publicised and any questions raised and answered published in the magazine.
- Visits to the northern zones needed to be cost effective. Monies could be utilised for training or conducting a one day workshop with a facilitator for stewards and show managers. Club infrastructure could be utilised and the workshop run in conjunction with a 'meet and greet' event.
- July 2025 Presidents and Secretaries meeting to be held to enable issues to be raised and discussed.

# Queensland RAFT Request

Directors discussed the information provided noting Dogs Queensland would not be able to hold a State or National Championship. Directors requested a wording change to the RAFT Rules to allow 'the use of either/or real or artificial game' be submitted to ANKC for reconsideration.
