

# DOGS QUEENSLAND LITTER APPLICATION GUIDE

## MEMBERSHIP

Breeder is a financial member and owner of a financial prefix before the date of mating.

Stud dog owner is a financial member at the time of mating.

## DAM

Dam is to be registered in the ownership of the Breeders Prefix.

Every owner of the Breeder Prefix is to sign the declaration at the bottom of the Litter Application.

*This declaration states the following: I / We, the breeder(s) / owner(s) of the above dog(s), certify that to the best of my / our knowledge and belief, the above particulars are correct and that all surviving dog(s) are included in this application, and I / we agree to be bound by the Constitution, Rules, Code of Ethics and Regulations of Dogs Queensland. I / We have read the adopted ANKC Ltd breed standard and declare to the best of my / our knowledge the colour of the progeny being registered conforms to the breed's accepted colours at the time of registration.*

Dam must be over 12 months of age at the time of mating - however please check the current Age limitations for specific breeds – refer to the Dogs Queensland Rule Book - APPENDIX 1 - ANKC LTD REGULATIONS PART 6

Dam can only whelp two litters in an 18-month period.

A Certificate of Fitness for the Dam will be required if 4 or more litters have been whelped or she is over 7 years of age at time of mating – this form is available on the Dogs Queensland website under LITTER REGISTRATION FORMS

If a semen Artificial Insemination of the Dam has occurred an Artificial Insemination certificate is required for fresh or frozen semen inseminations – these forms are available on the Dogs Queensland website under LITTER REGISTRATION FORMS.

A Dam imported from another country must have their re-registration paperwork certified as complete by Dogs Queensland before mating occurs.

## SIRE

Every owner of the Sire is to sign the Stud dog owner declaration at top the of the form.

Sire must be over 9 months of age at the time of mating - however please check the current Age limitations for specific breeds – refer to the Dogs Queensland Rule Book - APPENDIX 1 - ANKC LTD REGULATIONS PART 6

A Sire imported from another country must have their re-registration paperwork certified as complete by Dogs Queensland before any mating occurs.

Imported semen must be registered before or at the time of submitting a Litter Application relating to the semen.

## REGISTRATION APPLICATION form

All sections of the LITTER & STUD SERVICE CERTIFICATE REGISTRATION APPLICATION form or online application via [www.showmanager.com.au](http://www.showmanager.com.au) are required to be completed.

Provide date of mating and whelping – Gestation – is approx. 63 days

Number of male and female puppies written at the top of the form must equal the number of male and female puppy listings in the Litter Application.

Microchip number barcodes for the puppy are to be placed on the Litter Application.

First and second puppy registration name choices are required to be listed.

Puppy registration name can be up to 30 characters in length (includes the Breeders Prefix and spaces)

A Breeder can include another Breeders prefix at the end of a puppy name as a Suffix.

The owner of the prefix to be used as a suffix must provide a letter of authority for their prefix to be used in this way.

Puppy Colour as per the breed standard is required to be provided.

DNA numbers are to be placed on the Litter Application for all puppies.

If a puppy owner is a member of a Dogs Australia state body, please provide the membership number on the Litter Application.

Puppies are to be registered into the new owner's name at their residential address and/or postal address.

## FORMS REQUIRED - available on the Dogs Queensland website under LITTER REGISTRATION FORMS

- Limited register puppies require the new owners to sign a LIMITED REGISTER FORM
- Not for Breeding endorsements require the new puppy owners to sign a NOT FOR BREEDING FORM
- Not for Export endorsements require the new puppy owners to sign a NOT FOR EXPORT FORM
- Application for Export Certificate is required for any puppies being exported overseas on the Main register.
- Natural Bob Tail form or DNA report confirming Natural Bob Tail is required for puppies of breeds that are applicable - refer to the Dogs Queensland Rule Book - APPENDIX 1 - ANKC LTD REGULATIONS PART 6 for additional information.
- Partnership Agreement is required to be completed if a puppy is to be in co-owned with the Breeder
- Colour Assessment is required for Main registered FRENCH and BRITISH BULLDOGS – this can be via a Vet using the Colour Assessment form or three All-Breeds Judges.

French bulldogs, British Bulldogs, Pugs and Boston Terriers all conceived by Imported frozen semen are required to be physically inspected for Colour and Coat type by three All-Breeds Judges – please contact Dogs Queensland office for additional information.

## DNA PARENTAGE VERIFICATION as at 01/01/2023

DNA Parentage Verification is compulsory for all Main and Limited registered puppies born from 01/01/2023.

Sire, Dam and Puppy must have a DNA profile to verify the Parentage.

All puppies in the Litter must be DNA Parentage Verified including those placed on the Limited Register.

DNA samples must be collected by an Approved, independent, trained collector including Veterinarians.

Owner/breeders cannot collect DNA from their own dogs and will samples this way will not be accepted.

DNA Parentage Verification reports are to be included with the Litter Application at time of submission.

DNA Parentage Verification reports should be checked to ensure all information is correct - particularly the microchip numbers for the Sire, Dam and puppy, QUALIFY status and the Approved Collection method status.

## DNA PARENTAGE VERIFICATION

using Massey University managed by Dogs Queensland.

As of 1<sup>st</sup> January 2023, all Litter Applications submitted with Main or Limited register puppies are to be accompanied with a DNA Parentage Verification Report.

In line with the Dogs Australia protocol for DNA testing, DNA collection for the Sire, Dam and offspring must be performed by an approved independent collector. Identification of the dog by microchip or unique tattoo is required and it must be verified by the approved collector at the time of DNA collection and recorded on the appropriate form.

Transfers from the Limited to Main Register, where the Dam was mated after 1 January 2018, would similarly have to be accompanied with a DNA Parentage Verification Report.

Dogs Queensland co-ordinates the DNA Parentage Verification in conjunction with Massey University. This simplifies the DNA process and enables all members (regardless of computer skills) to easily place an order with Dogs Queensland for parentage.

Although Dogs Queensland preferred DNA provider is Massey University, members can use any DNA provider of their choice and submit the Parentage verification reports to Dogs Queensland.

Dogs Queensland's members that need additional breed specific disease or colour testing can have these tests performed with the Massey University partner lab at a competitive price.
